- Olivia Stevens called about slow drains in Ripley. She called a plumber & they thought they were hitting tree roots but they should not have them in a new system. Same thing happened today and she called Always Available. Has not heard anything back.
- Picked up a new strobe light for the truck.
- Going to a Miss Dig Seminar on 1/25. There is no charge.
 - They are currently doing emergency Miss Digs only due to the snow.
- Average 37,685 gallons per day
- Price from Bay Electric for replacing the pump is \$6,860. Could fund from Repair, Replace & Improvement account.
- Will from HCRC is going to change the light & make sure it gets done today in Ripley.
- Trustee Dulong stated that the truck may need new tires and we should include in the budget for next year.

Clerk Yeates reported the following:

- O&M was short for the end of the year bond payments by \$2,144 which was borrowed from the General Fund to make the payment.

- BS&A software is at the municipality level so it can be downloaded multiple times on either personal computers or on a server.
