This report is for growers who market their wheat directly to end users. For growers who sell their wheat to grain handlers, handlers will collect and forward the assessment to the Commission.

Procedures for the collection of the California Wheat Commission assessment established	in
accordance with California Food and Agricultural Code Sections 72001 et seq.	

- 1. An assessment of TWELVE AND A HALF CENTS PER HUNDRED POUNDS (\$0.125 per cwt.) shall be paid by the producer on all wheat grown and sold. The assessment is a personal debt of every producer so assessed. Failure of a handler to make payment of the collected assessment to the Commission shall not relieve the producer of this obligation.
- 2. Collection of the assessment shall be made by the handler at the point of first sale by the producer by deduction from the total amount paid to the Producer. The handler shall be a trustee of the funds until they are paid to the Commission. Every handler shall be personally liable for the payment of the collected assessments, and failure of the handler to collect the assessment from any producer shall not exempt any handler from liability for payment of the assessment.
- **3.** Wheat which is grown under contract or which is sold on a consignment basis shall have the assessment collected by the handler at the first point of sale by the producer.
- **4.** Producers who sell their wheat to other producers for seed or other purposes shall complete the assessment report, calculate the applicable assessment themselves, and remit it to the Commission.
- **5.** Wheat seed handlers who buy wheat for seed or other purposes shall collect the assessment at the point of purchase from the Producer.
- **6.** Any producer or handler who fails to file a report or pay any assessment within the time required by the Commission shall pay to the Commission a penalty of 10 percent (10)% of the amount of such assessment determined to be due, and in addition, shall pay 1-1/2 percent interest per month on the unpaid balance.
