### PERSONAL INFORMATION

This information includes items specific to each User and can be used to identify HHT users uniquely. Examples include:

- First and last name for app functions: fraud prevention, security and compliance, account management
- Address (Optional) for account management
- Telephone Number for app functions: login account, register account.
- Email address (Optional) for account management

### LOCATION INFORMATION

- Search nearby friends, nearby stores, nearby services: dining, entertainment
- Share location of user to their friends via chat

### **MESSAGES INFORMATION**

 OTP authentication code sent to users in the following cases: new account registration, withdrawal, forgot password

## PHOTOS AND VIDEOS INFORMATION

#### Data collected, and for what purpose:

- Videos (Optional) for app functionality: sharing files in chat's feature, set profile avatar, post news, post video, post products, post services,...
- Photos (Optional) for app functionality: sharing files in chat's feature, set profile avatar, post news, account settings, post products, post services, create a community group,...

Our website and application may collect user images and videos for various purposes, such as profile pictures or content submission. Please be aware that any images and videos ubmitted to our platform may be stored on our servers for future use. However, we do not share these images and videos with third parties; they are only used for internal purposes,

such as improving our services and user experience. By submitting an image and video to our platform, you acknowledge and consent to our collection and storage of your image and video.

### **AUDIO FILES INFORMATION**

- Voice or sound recordings (Optional) for app function: sharing files in chat's feature
- Music files (Optional) for app functions: post news, sharing files in chat's feature.

#### FILES AND DOCS INFORMATION

 Files and docs (Optional) for app functionality: sharing files in chat's feature, update legal information in account settings, post product information and service information.

#### CONTACT LIST INFORMATION

The application will collect contact list information to enable contact synchronization in the application, in the scenario:

- Phone number: to automatically add friends in the application when both parties save the phone number each other's phone number.
- Contact name: to synchronize the name in the contact list with the name in the application's friend list when the user saves the phone number of the friend.

The user's contact list information use is not published or disclosed for any other purpose without the consent of the user, it is encrypted and completely secure.

### **APP INFO AND PERFORMANCE**

 Crash log for function: collect the number of times the app has crashed, stack traces, or other information related to crashes to fix-bug.

## **DEVICE OR OTHER IDs**

- Send notification from HHT's system to user's device.
- Save the logged in or logged out status of the device.

### UPDATE OR DELETE INFORMATION.

The User can use the feedback form on the website or software to notify HHT of any updates, changes, or corrections to their previously collected information. In addition, upon user request, we will use our reasonable business efforts to remove user information from our databases; however, it may not be possible to completely delete user data due to support data or deleted records.
