2/27/2024 - We are still awaiting the Police Report on the missing rifle. We are unable to address the subject without Mr. Beasley being present. We have to wait to turn in the remaining rifles until this report is complete.

*6/25/2024 – Attempts to contact the investigator have not been returned. Mr. Lowe will continue to contact. Motion to retain rifles to use as ceremonial events. The use would be for static events for color Guard and not for firing due to the safety issue. Last firing at a memorial two of the rifles jammed. We received positive response from visitors at the ceremony that we did not fire the rifles. The need to have a gun safe is a requirement which would be \$500 to \$1000. Desired storage is at a Police station or Armory. Motion: Table the turning in of the rifles once we receive the police report to take a better look at retaining some or all of the rifles. Mr. Studdenbeck does not approve the retaining of the rifles due to the safety issue. That if we retain them someone will try to shoot them. Is there a way to make them static? **Motion to Table turn in of rifles - 7 Approved, 1 Abstained, 0 Disapprove***

d. Flag Drop-Off container

2/27/2024 - Motion was to place a flag drop off container at Platte City. Which will expand to communities around and not just a Weston organization. Will bring up as unfinished business at the next meeting.

3/26/2024 - This container would require maintenance and collection by a member. We don't have a plan worked out. We do have a member that goes by the YMCA twice a week. Ms. Franco has a contact that would help with turning in for burning by Boy Scouts. There is one at Sharps Market and another at City Hall. This one would be for Platte City. No new information received so a motion was raised to Table again. **Motion to approve - Approved 7 Abstained 0 Disapproved 0**

6/25/2024 - Motion made to not do the Flage drop off container and coordinate with the Scouts to help in some ways. We could possibly go to Platte City later and focus currently on Weston. **Motion is to help the logistics of the Scouts in Weston - Approved 7 Abstained 0 Disapproved 0**

e. Insurance for Bonding

2/27/2024 - We have received 3 quotes of which one is from Savannah, Mo and another from Platte City. We are looking for the least expensive. It is insurance in case of lost funds. Cost is between \$700 and \$1,000. With the \$600 we put toward Boys State it

leave us will \$2,300 in operational budget. Taking another \$1,000 would bring us to \$3,300. This will limit us to support other programs until the CD starts bring in additional interest payments. Need to have the Commander and Financial Secretary bonded upon getting appropriate quote.

3/26/2024 - Mr. Lau asked about the Post being part of the Chamber of Commerce. The Moonshiners organization (which he is a member) is a part of the Chamber of Commerce and a member of the Chamber of Commerce you are covered with Liability Insurance. It would have cost the Moonshiners \$500 a year in liability insurance for their organization. Once you pay that \$75 fee you are being included in the liability insurance coverage. We will table that portion of the discussion. Question of is liability required. No it is not required but highly suggested. Bonding is a requirement. Question: Ms. Prior - Are you bonding the person or the Position? We are bonding the two officers that have check writing abilities. It is a requirement by the American Legion. Since there are two individual that have check writing authority then they both have to be bonded. We are only bonding the operational fund check writers. The CD requires two signatures to remove funds so no bonding is required. Ms. Prior suggested that we bond the position and not the person. Her previous organization was bonding based on the income of that position. We might want to consider changing the one person check writing. Motion to bond costing \$100 for two positions through NFP.

3/26/2024 - Recommend purchasing liability through MO Rural for \$515 **Tabled for further investigation.**

Recommend purchasing bonding through NFP \$50/\$100 for \$10,000. CD requires dual signature. **Motion to approve - Approved 7 Abstained 1 Disapproved 0**

6/25/2024 - Bond has been approved so the Post has been bonded by an insurance agency and this portion of the agenda can come off next month. Since the CD is two signature required we do not have to bond for that portion. We will keep on the insurance and drop off the Bonding portion.
