SUMMARY

There are many similarities with the growth and trajectory of impact investing in Canada and Colombia. One of the key factors for the growth of the Canadian ecosystem over the last decade has been the opportunity for Canadian leaders to visit and connect with other nations engaged in this work, through informal and formal study tours of countries such as the UK and the United States. There is an interesting opportunity for similar sharing and learning with leaders from Canada and their counterparts in Colombia. Accordingly, SVX is hosting a study tour in Colombia for Canadian investors, advisors, and impact investing ecosystem leaders from November 5 -8.

Drawing parallels with the growth trajectory of impact investing in Canada, we believe that immersive experiences in countries like Colombia can catalyze the Canadian and global impact investing ecosystem.

This is a unique chance to engage with your peers and counterparts in Colombia, fostering long-term collaborations. In particular, it may be interesting for folks interested in climate action and biodiversity, gender lens investing, inequality, rural economic development, health, and housing.

The study tour has the following target objectives:

- Deepen **relationships between key actors in Canada** through an immersive multi-day experience in the Colombian impact investing ecosystem;
- Support capacity building for both the impact investing ecosystem in Canada and Colombia;
- Create **bilateral connections** and begin to create long-term linkages between Canada and Colombia in impact investing, by connecting peer investors and leaders in a safe environment;
- Support mutually beneficial **knowledge exchange** including models and approaches to impact investing in Colombia to bring back lessons learned and best practices that could inform the development of new interventions in Canada; and
- Build understanding of Colombian impact investing market amongst Canadian leaders.

We are seeking the following target outcomes to show success following the study tour:

- **Growth in engagement and commitment** by Colombian and Canadian investors and leaders in impact investing, including investment in both Canadian and Colombian opportunities;
- Enhanced capability of impact investing intermediaries in Canada and Colombia based on knowledge exchange;
- Adoption of new models, tools and approaches to impact investing, from public policy to investment strategies, based on insights gained;
- New relationships between Canadian and Colombian leaders may result in future **collaboration**, from knowledge sharing to co-investment; and
- **Develop Canadians as ambassadors and champions** of the Colombian impact investing marketplace.
