### **Agency Announcements:**

**ADVOCAP Bridges Program:** Bridges assisted 29 Households totaling 47 people. Bridges has been slower with not as many utility calls.

**Day by Day Warming Shelter:** Shelter has closed until October. Day by Day has started their outreach days which are usually Tuesday and Thursday from 10 am - 2 pm. They are working on a feasibility study for a year round shelter with the goal to open Fall 2019. **Legal Action:** Keep sending referrals.

**Fair Housing:** Fair Housing also has an Outreach coordinator position open in the Milwaukee area. Apply at Milwaukee jobs.com.

East Central WI Regional Planning Commission: Kathy handed out the Winnebago County Transportation Facilitation work sheet which is a table with goals, activities and roadblocks that was created with the help of the committee for the Winnebago County Specialized Transportation Coordination Plan. This 5 year plan is a requirement for Federal Transit Administration (Section 5310) and WisDOT (85.21) transportation funds for seniors and individuals with disabilities. The City of Oshkosh is nearing completion on their comprehensive plan. The next step is a 30 day public review period before adoption of the plan by the City Council. We are currently in the process of selecting a consultant that will be assisting with developing a I-41 Commuter Service Study to determine the feasibility of providing bus service along the I-41 corridor from Green Bay to the Fond du Lac area.

## **FISC:** No updates.

Oshkosh/Winnebago County Housing Authority: WCHA was awarded 5 VASH vouchers (Veterans Affairs Supportive Housing) starting 6/1/18. Please call Heather Grasse at 920-431-2500 if you know of a veteran in need of housing. Waite Rug project interest list is at the HA front desk. When Waite Rug is nearer to completion, these interested people will get notified. 1<sup>st</sup> and 2<sup>nd</sup> shift Daycare construction is scheduled to start in July. WCHA is revising the Administrative Plan for the Housing Choice Voucher Program and is scheduled to be completed by the end of July. Wendy Fromm was hired as the property manager of Raulf, Riverside and Foxview properties.

**Salvation Army:** On June 16<sup>th</sup>, Salvation Army will have its 2<sup>nd</sup> annual Pedal out Hunger to support Salvation Army's Food pantry and their other programs. Please go to

**Winnebago Apartment Association:** Act 317 Bill passed to include: No inspection of a rental unit may be conducted under this subdivision if the occupant of the unit does not consent to allow access unless the inspection is under a special inspection warrant under s. 66.0119.

City Of Oshkosh: The city received \$815,000 from CDBG to be used for: blight properties, Day By Day Warming Shelter permanent location, lead grant for Waite Rug Daycare, Public Service Agencies, funding Fair Housing council, and salaries etc. Oshkosh Yearly Action plans are open for comment. ### **Discussion: Presentation by Steve Cole & Lynn Coriano from POINT:**

POINT is a Partnership with Institute for Healthcare Improvement (IHI) to teach Continuous Improvement (CI) tools to organizations in the region. They started providing Six Learning Sessions over the course of 18-months and monthly all-team calls + monthly action group calls from Feb 2017 – Sep 2017. Now they have 25+ local CI Coaches from companies across the region and 4 Action Groups currently convening, using CI tools, and paired with local CI coaches to explore and align collective action in jobs, trauma informed approaches, housing, and life skills. POINT Strategies to Address Poverty are: Build Organizational Capacity (access tools), Build Community Capacity (CI coaches + skilled volunteers, and Build System/Region Capacity (Shared Data Systems + Strategy). Feedback from POINT Participants after 18 months:

- 1. Participants want to convene on a regular basis to learn, network, be inspired, and advance knowledge across the region;
- 2. Priority in enhancing data/measurement tools and better understanding regional data and progress in reducing poverty;
- 3. Interest in POINT playing a role in engaging in community awareness efforts that advance cross-sector advocacy and policy efforts;
- 4. Increase communication re: evolving direction and strategy; and
- 5. High value placed on CI Coaches and want this piece to continue.

With the implementation of the Coordinated Entry System, there have been a number of challenges identified that are extending the time that it takes to move individuals through the system. These challenges are preventing the new system from becoming a best practice. POINT worked to put together a Coordinated Entry Brochure 101 to speed up

the process. They have also worked to standardize data collection. Next step is to analyze the data. Homelessness as a whole is decreasing according to the data collected, but the graph does not take into account of doubling up or the difficulty of counting homeless people who are unsheltered. All are invited to the Next Learning session (education focused) on June 20<sup>th</sup> from 8:30 am to 5 pm. For more info, please call Lynn Coriano at 243-2596. If you want to learn more, connect with a CI coach who can provide coaching, mentoring and continuous improvement support. Local impact: Samaritan Counseling was having no shows for appointments. Small testing was done by calling or texting to remind people of their appointments. They found calling to remind people showed no difference in people keeping appointments. Text reminders saw an improvement in people showing up for their appointments. Amanda would like to put a coordinated entry subcommittee together. If interested, please contact Amanda at 203-4536. We would need to invite FDL and Green Lake coalition members to the table.
