BIDS

1. AHS ELEVATOR LIFT BIDS

Mr. Black presented bid information to the board on the AHS Elevator Lift replacement. He said the district received bids from two companies; Home Elevator Co., Wichita in the amount of \$19,500 and Access Elevator & Lift, Lee's Summit in the amount of \$26,250. Mr. Black told board members the administration recommended the approval to accept the bid from Home Elevator Co.

After discussion, Mr. Rinkenbaugh made the motion to approve the recommendation to accept the bid from Home Elevator Co. in the amount of \$19,500, to replace the lift for the high school elevator.

Ms.Lee provided the second and the motion carried 7-0.

2. SOFTBALL CANOPY BIDS

Mr. Black presented bid information to the board on the purchase and installation of six more Softball Canopies. He said the district received bids from Compton Construction in the amount of \$59,100 and Speciality Contractors in the amount of \$75,000. He also reminded the Board the cost of the canopies will be reimbursed by the Augusta Girls Softball League.

After discussion, Mr. Rinkenbaugh made the motion to accept the bid from Compton Construction in the amount of \$59,100, to purchase and install six more softball canopies.

PURCHASE OF BOX-PANEL TRUCK, SPECIFICATIONS
