

Privacy Policy Overview (Last updated: September 17, 2024)

This Privacy Policy outlines how we handle the collection, use, and sharing of your personal information when you use our service. It also explains your privacy rights and how the law safeguards your data. By using the service, you consent to the collection and usage of your data as per this policy.

Key Definitions:

- **Account:** Your unique access to our service.
- **Affiliate:** An entity connected through common ownership.
- **Application:** Refers to *Sangathan Posters*, our software.
- **Company:** Sangathan Posters (referred to as "We," "Us," or "Our").
- **Country:** Refers to Delhi, India.
- **Device:** Any device accessing our service (computer, phone, tablet).
- **Personal Data:** Any information that can identify you personally.
- **Service Provider:** Third parties that process your data on behalf of the Company.

Data Collection

We collect:

Use of Personal Data
