

Terms of Service for Vagoncho's Commissions

General Information:

*As an **artist**, I am in full right to accept or deny a commission, whether for personal reasons, the themes of the drawing, the customer's attitude, etc.

*You are dealing with a person who, even if I wanted to, I am just a casual/hobby artist, not a professional or expert in the fine arts, take that into consideration.

**At the moment I do not know what else to put here.*

Things the artist MAY or MAY NOT draw:

*As an **artist**, I have some major interests for one thing or another, as there may be things that I dislike or do not care to draw, as well as things that I do not accept to draw because of the complexity of it, as well as the possibility that I know from the beginning that I can not provide a good product.

*I am willing to work on both SFW and NSFW commissions, just because there is a price sheet that features only SFW or NSFW content is no indicator that I am limited to something pornographic or something suitable for all audiences.

***THINGS I WILL DRAW** *(with possible exceptions based on points made previously or later):*

Bipedal, quadrupedal, more humanoid or more wild looking creatures (in short, many things you can classify as "*anthro*" or "*feral*"); humans; pinups; simple poses or with some movement; explicit content; M/F, M/M, F/F couples; shitpost or attempts at humorous stuff; simple little scenarios; individual comic pages; icons; "21-year-old human" characters equivalents or their real or fictional species equivalents for NSFW content; among other things. You can always ask if you see something that is not listed below.

***THINGS I WILL NOT DRAW** *(with possible exceptions based on points made previously or later):*

Kinks related to personal hygiene such as scat, urine, extreme sweating, etc; violence, rape, gore, vore and other things that are taken to the extreme; characters belonging to other artists that have not been previously authorized to use *(read here the most casual artists or those who average on the internet, obviously I do not include the big companies that obviously would not approve the use of their intellectual properties in any way, less in an environment like this... hypocrisy? yeah)*; ultra detailed scenarios; characters with too many color palettes or overloaded with details; among many other things that I can't think of right now; ANY character who is a minor, either the equivalent of 18 years of age for humans, or any "equivalent" to both real and fictional species.

Workflow:

- *After the basic concept or idea of the commission is agreed between the commissioner (**You**) and the artist (**Me**), I will begin to do the pre-sketches. I may respond with an update within a few days, to a maximum of a week.
- *The pre-sketches/concept ideas can be done as many times as necessary.
- *Once I start to do the sketch, I'll update you with the progress of the commission, and I'll be able to change basic or medium details (*for example, a pose, some objects in the background, etc*) without charges.
- *When I start doing the rest of the work (*lineart, coloring, etc*), I won't be able to make big corrections except for small or specific details.
- *If you want the commission to be private or published on a predetermined date, specify it.
- *While it is not a private commission, I have the right to publish the art piece in my galleries or social networks.
- *My signature(s) whether they are a brand, or an address to my main gallery or social networks, must be retained. Likewise, every drawing will have a textless version of them.

The communication:

- *I live in Argentina, so if you don't know what time I can be available, you can see the time difference of your country to mine (UTC-3).
- *You can contact me preferably either through my Discord account for commissions (**VagonchoComms**, old alias **@VagonchoComms#4480**), or via PM/Note [at FurAffinity](#), also on any of the other platforms on which I'm on like Twitter (*but I don't usually check them often*).
- *I will try to do my best to respond to any messages, questions, and commission inquiries as soon as possible.

Payment information:

*I accept payment through [PAYPAL](#) invoices only.

(For now, although I am considering other alternatives such as cryptocurrencies or bank accounts in the United States...).

*All prices are in **USD** (United States Dollar).

*The service will be paid at the moment the commissioner gives the OK to the pre-sketch.

*Once I've started doing the sketch, **the payment is not 100% refundable.**

*In the event of any inconvenience on the part of the client or the artist that damages the business between both parties, a **refund** may be made according to the percentage of the **work not done** against the **work already done**.

*Once advanced to intermediate or final stages of production, there is **NO** margin for refund. And any attempt that may be detrimental to the artist (*e.g. a counter-refund once the work has been completed and approved*) will be added to a **blacklist**. *It may sound very strict but one always has to be legally cautious, I guess?*

*Once the commission is **finished**, I will send to you a .rar/.zip with the .png, .jpg and some alt/s if it is available to the commissioner.
