NOTE: AS PER GOVERNMENT RULES A CONSUMER IS ALLOWED TO HAVE ONLY ONE LPG CONNECTION. SINCE PIPED GAS CONNECTION IS ALSO CONSIDERED AS A CONNECTION ONCE WE START USIG PIPED LPG WE ARE REQUIRED TO SURRENDER THE LPG CYLINDERS WE ARE USING. IT CAN BE SURRENDERED TO THE GAS AGENCY FOR SAFE KEEPING AND RECOVERED IF NEEDED LATER.

FORM SHOULD BE COMPLETED IN ALL RESPECTS. INCOMPLETE FORMS CANNOT BE ACCEPTED.

PLEASE READ AND SIGN THE TERMS AND CONDITIONS TO COMPLETE THE APPLICATION. APPLICATIONS WITHOUT AGREEING TO THE TERMS AND CONDITIONS WILL NOT BE ACCEPTED.

TERMS AND CONDITIONS

My application for domestic piped LPG supply through NST's piped gas network is subject to the following terms and conditions:

- 1. By submitting the application with refundable deposit applicant is deemed to have unconditionally agreed to these terms and conditions.
- 2. Applications received without realising payment of refundable deposit will not be accepted for providing this facility.
- 3. Owner of the flat applying for this facility must be a member of STOWA.
- 4. Understand that STOWA is managing payments for LPG supplied by government gas company at rates fixed for domestic LPG (without subsidy) entirely through funds collected as refundable deposit and payments received for LPG consumption from all users of this facility. Hence any default in payments will result in shortage of funds to run the supply smoothly.
- 5. ALL TENANTS ARE REQUIRED TO SUBMIT A NOC FROM THE OWNER IN THE PRESCRIBED FORMAT BEFORE APPLYING. TENANTS REQUIRING URGENT CONNECTION WITHOUT NOC SHALL PAY ADDITIONAL CONNECTION DEPOSIT OF Rs 500/- WHICH WILL BE ADJUSTED WITH BILL ON RECEIPT OF NOC ONLY. IF NO NOC WAS SUBMITTED ATLEAST 1 MONTH BEFORE VACATING THIS AMOUT SHALL BE FORFEITED AND NOT BE REFUNDED AT THE TIME OF VACATING.
- 6. Payments for usage will be made on the basis of monthly consumption readings taken from the LPG meters installed in ground floor of NST. A monthly consumption statement indicating LPG consumed by each user will be generated against which payments will have to made before the payment due date (10th of every month). Consumption statement shall be posted in the GAS WhatsApp group. (Subscriber to ensure that contact number is included in the Gas WhatsApp group by informing Mr. Saravanan, Navins Maintenance).
- 7. All payments shall be made ONLINE to STOWA BANK ACCOUNT using the VIRTUAL ACCOUNT NUMBER FOR PIPED GAS ASSIGNED TO YOUR FLAT (IFSC CODE ICIC0000106) and transaction details shall be communicated in the gas Whatsapp group indicating the FLAT NUMBER and AMOUNT.
- 8. SUPPLY OF GAS WILL BE CUT-OFF IF PAYMENT IS NOT RECEIVED BY THE DUE DATE. A RECONNECTION CHARGE OF Rs.150/-MUST BE PAID FOR RECONNECTION. THOSE GOING OUT OF STATION MAY PAY ONLINE AFTER SEEING THE MONTHLY BILL POSTED.
- 9. Application for discontinuation of the service will be given effect after the next billing cycle date. Refund of interest free deposit will be processed within 15 days of the next billing cycle date. 50% Service Charge advance will be refunded if number of months elapsed since payment of advance is less than 6 months.
- 10. The connection is understood to have been provided for domestic use only in my flat for one stove which will be commissioned by the service provider. No alteration shall be carried out on his/her own by the consumer. Under no circumstance shall the consumer make use of the supply for any commercial purpose.
- 11. Navins Maintenance has awarded an AMC for maintenance and operation of the piped gas network and all its associated functions like metering, safety controls etc and consumers may approach Navins maintenance in case of any problem of LPG supply. Since inherent safety features are built-in the system, any untoward use or tampering can disrupt supply. Users shall therefore seek maintenance staff assistance in case of any necessity.
- 12. Normally uninterrupted LPG supply will be available however users should be aware that a short outage of few minutes could occur when the gas lots are switched when one lot under use gets exhausted. Please call maintenance or security if gas runs out.
