

Privacy Policy

Your privacy is very important and significant to us. We release this Privacy Statement to protecting your privacy. We guarantee that our app will apply for privacy rights only to help users better manage the use of the app. This Privacy Statement is to inform you what information we collect and how we use it to continually optimize your experience. Please take a few minutes to familiarize yourself with this Privacy Statement and contact us if you have any questions.

This Privacy policy is for the resident of EU, EEA, Switzerland and people from any part of the world.

Collection of information

The data we collect depends on the context of your interactions with us, the choices you make, including your privacy settings, and the products and features you use. The data we collect can include SDK/API/JS code version, browser, Internet service provider, IP address, platform, timestamp, application identifier, application version, application distribution channel, independent device identifier, Android ad master identifier and international mobile device identification code (IMEI) The equipment model, the terminal manufacturer, the terminal device operating system version, the session start / stop time, the location of the language, the time zone and the network state (WiFi and so on), the hard disk, the CPU, and the battery use, etc.

Account information security

A) Account has safety protection function of our apps, please take care of your user name and password information. We will ensure that your information is not lost through encryption and other security measures of user password, misused and altered. Despite the security measures, but also please Caution! Perfect measures does not exist "in the information network".

B). Please properly protect their personal information, only provide to others in case of need. If you find your own personal information leakage, especially our apps username and password leak occurs, please immediately by our mailbox contact our apps product related staff, so that we can take corresponding measures in time and effectively.

Mobile Analytics

We use mobile analytics software to allow us to better understand the functionality of our Mobile Software on your device. This software may record information such as how often you use the application, the events that occur within the application, aggregated usage, performance data, and where the application was downloaded from. We do not link the information we store within the analytics software to any personal information you submit within the mobile application.

International Transfers of Personal Data

Our business may require us to transfer your Personal Data to countries outside of the European Economic Area ("EEA"), including to countries such as the People's Republic of China or Singapore. We take appropriate steps to ensure that recipients of your Personal Data are bound to duties of confidentiality and we implement measures such as standard contractual clauses. Legal basis for data processing

We process Personal Data for the purposes set out in this Privacy Policy, as described above. Our legal basis to process personal data includes processing that is: necessary for the performance of the contract with you (for example, to provide you with the services you request and to identify and authenticate you so you may use the Sites); necessary to comply with legal requirements (for example, to comply with applicable accounting rules and to make mandatory disclosures to law enforcement); necessary for our legitimate interests (for example, to manage our relationship with you, to ensure the security of our services, to communicate with you about our products and services); and based on consent by our customers (for example, to place certain cookies and to share your information with third parties for advertising purposes). In some instances, you may be required to provide us with Personal Data for processing as described above, in order for us to be able to provide you all of our services, and for you to use all the features of our Sites.

Other Information:

GET ACCOUNTS

This permission is needed for making a selection list with your google accounts in the app, when you are exporting/importing photo or video data to/from google drive.

ACCESS NETWORK STATE

This permission is needed for checking if you are connected to the internet when you install our applications.

INTERNET

this permission is needed for exporting/importing data to/from server.

CALL PHONE

this permission is needed for starting a call from the applications.

Location information

while using our GPS location apps we may collect your location through GPS or Wi-Fi. Location information will only be used when you give us permission. We did not share your location with anyone else we just use it to show you your current location on google map.

Take pictures and videos

this permission is use only for camera application or flashlight apps. This app will allow to take picture or videos. It does not send video to any third party but only save into your device.

WRITE EXTERNAL STORAGE

this permission is needed for writing to the external storage of your device when exporting our applications data to the device's internal storage.

Read your contacts

we don't read, save or upload your contact. This permission is use only to access your contact info when you allow. This permission is use in caller name announce apps to read your contact name.

Change the privacy protocol

We reservations at any time on "Online Privacy Ordinance" to revise, delete or change the rights of other privacy policy. Any amendments and updates are immediately published in Webpage.
