Hello all,

First, we would like to sincerely apologize for the amount of time it's taken us to get this update out to you all. We meant for it to come much sooner but the hijacking incident (and investigations needed in the time after) delayed it quite a bit. We are also a small team still struggling with the loss of our friend and leader. We have worked countless hours and are admittedly worn down from everything that's happened. We will be making a separate post on the hijacking incident and the details we are able to share. Today's post is an in-depth look at our GoFundMe including a detailed breakdown (and graphs!).

We are absolutely stunned that we met our funding goal thanks to all you wonderful members of the community! We know there are still many questions and we hope to answer as many of them as possible. Please know that there are some items we have to be vague about to respect the family's privacy or for legal reasons. That said, we will share everything we can. Transparency is paramount and the least we can do as a thank you during this difficult time.


Some have shared concerns that we would hit this goal only to raise it again. We want to state that at this time we have no plans to increase the goal even if more debt is found. The amount given by the community is astounding and we are very grateful! We feel we are going in an incredibly positive direction and appreciate the continued donations to the drive. Now that the gears are in motion with lawyers, we need to wait and see how things play out. We'll make sure to keep you informed as we hear more.

The goal is still to keep the business out of probate and Dragoneer's family is working with us in this regard. There is only so much we can do without a will in place, but the lawyers also know our wishes and are working with our best interests at heart.

### **GoFundMe Breakdown**


The details below outline the funds raised and what the money has been put towards so far.

After transaction fees are deducted from the total we are left with \$216,668.12.



The graph below shows broad categories for how the funds are (or will be) used. The graph numbers round up to the nearest dollar amount. We will provide as much detail as we can in each category, but please understand that there are a few things we are **legally** required to keep vague for the time being. There are also a few things we need to keep vague to respect his family's wishes.



### **Support to Rita**

We have given a lump sum of \$40,000 to Rita (Dragoneer's mother) so she can take care of what she needs to and work out the medical debts we know about so far. Because medical details are a personal (and HIPPA-protected) subject, we prefer to let her manage that, and have provided some buffer if needed. Our previous update had medical debt at \$38,300.

### Mortgage

Not included in the \$40,000 to support Rita (and not included in the graph above) is **\$12,057.84** to cover six months of mortgage payments on Dragoneer's house for Rita, plus some extra for breathing room. This amount has not been paid yet, but that is the total after getting the exact monthly cost of the mortgage (\$542.16 less than anticipated).


### **Travel**

Another item missing at this time is **travel**. We originally set aside \$1,000 to help Rita with traveling across states for the duration of this, but we are unfortunately already over that amount. When we made our original estimate we were under the impression we would be staying in Dragoneer's house to save funds. We were surprised to find out that we could not stay at his house August 16-21 while managing his home and affairs. We will make sure this amount is updated, however the cost of the hotel for our stay was **\$1,219.80**. We have made sure this issue has been resolved and we should not need a hotel again moving forward.



This is JUST for the probate lawyer so far. More lawyers will be coming into play for the business and for the family. We cannot go into further details other than the overall costs as things progress. As other lawyers are brought on they will be given numbers to tell them apart. If

we learn any information that we are allowed to share, it will be included in future updates. We do not yet know the cost of other legal matters so we have left them as unknown for now. We still need to be prepared for those costs, so if we have extra funding, part of it will be held for this.



This is a very sensitive and delicate category so please understand that we have to be vague about some details.

**Funeral Home Services:** This is to pay the funeral home for cremation and urn costs.

Medical Examiner: We have been asked not to go into details of this matter at this time.

**Bereavement Home Services:** This is also something we've been asked to not go into details about.

Things not included in this are costs for both the private family funeral and public celebration of life. Right now those costs are estimates alone and nothing has been paid into them. The estimates stand at their original amount at \$3,000 and \$8,000. If that changes in any way we will be sure to keep you updated. The family funeral will not have details given, but we will be transparent with information about the public service.



We originally budgeted \$20,000 for one month of keeping operations going. \$19,349.95 was spent for this. The remaining amount will go towards the next month's funds needed while we work through this transitional period.

**Contractor pay for August: \$12,300** was used to pay current contractors working for the site. We hope to continue payment through September using funds to keep operations running smoothly.

**Server Host:** Our server host charges **\$5,200** monthly (for colocation, network, power, on-site maintenance, support, monitoring and a filtered inbound connection with DDoS protection.)

**Prior contract services owed: \$1,500** paid towards the amount owed to previous contract obligations Dragoneer had in place. There is currently **\$36,250** left to pay off, but an agreement has been put in place that we make monthly payments until that debt is paid in full.

**Third-party services:** \$260 a month covers our CDN and site security. \$89.95 for email services.

### **Additional Costs**

There are some costs missing from this that still need to be looked into and paid. We have not put anything into these amounts as we hope with time the lawyer might be able to work some of them down. We are preparing for the worst though. Receipts will be provided. As mentioned before, we have no plans to increase the goal even if more debt is found.

\*\*We cannot apologize enough for this drastic change in amount. We originally listed the remaining IMVU debt as \$17,000 after confirming it twice with our IMVU representative. After further investigation we learned the amount left is \$83,800. While this was not an error on our end, it's a shocking update nonetheless. IMVU is still willing to work out payments with us and have no interest in putting site ownership at risk. IMVU is equally in shock by Dragoneer's passing and wants to do all they can to support us and help this go smoothly.
