

Privacy Policy

Thank you for using Cloud Backup and Restore ("App"). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our App, including any data you provide to us when using the backup and restore functionalities. We value your privacy and are committed to protecting it.

If you choose to use our Service, then you agree to the collection and use of information relating to this policy. The Personal information that we collect is used for providing and improving services. We will not use or share your information with anyone except as described in this Privacy Policy.

1. Information We Collect

We do not collect any personal information when you use the backup and restore functionalities of our App. However, during the backup process, certain non-personal data related to your device and App settings may be collected to facilitate the backup process. This may include:

- Device model
- Operating system version

We may need the following permissions in order to complete the backup and restore process.

- **All Files Access:** Our App may request permission to access all files on your device to perform certain functionalities like backup and restore of images, documents, Zip/Archive files.
- **SMS Permission:** SMS Permission: If you grant our App permission to access your SMS messages, we may collect and process SMS data to provide specific features, such as SMS backup and restore. We do not store the content of your SMS messages on our servers.
 - **Default SMS Handler:** Before read/write SMS, you need to set our app as Default SMS handler. After completing the restoring process you can use the previous app as default SMS handler.
- **Call Logs:** With your permission, our App may access your call logs to provide features such as call history backup and restore.

- **Contacts:** Our App may request access to your contacts to facilitate functionalities such as contact backup and restore.
- **Calendar:** If you grant our App permission to access your calendar, we may collect and process calendar data to provide features such as calendar backup and restore.
- **Apps:** If you grant our App permission to access your apps apks not apps data, we may collect and process apps apks to provide features such as apps backup and restore.

2. How We Use Your Information

The information collected during the backup process is used solely for the purpose of creating a backup of your App data and restoring it when requested by you. We do not use this information for any other purpose.

3. We Will Not Store Data or Use It for Commercial Purposes:

We do not store the information collected through the permissions mentioned above on our servers. Additionally, we do not use this information for commercial purposes, such as selling or sharing it with third parties for marketing or advertising purposes.

4. Third-Party Services

We may use third-party services to facilitate certain functionalities of our App, such as cloud storage providers for data backup. These third parties may have access to your information only to perform tasks on our behalf and are obligated not to disclose or use it for any other purpose.

5. Data Security

We take your privacy seriously and implement appropriate security measures to protect against unauthorized access or alteration of your personal information.

6. Children's Privacy

Our Service does not address anyone under the age of 13. We do not knowingly collect personal identifiable information from children under 13. If you are a parent or guardian

and you are aware that your child has provided us with personal information, please contact us so that we can take necessary action.
