## **Privacy Policy**

This Privacy Policy explains in detail how we collect use share and protect your personal information when you access and use our app and the services it offers We want to be completely transparent about what data we collect why we collect it how we use it and how we protect it so you can have full confidence in using our app

When you use our app we collect certain personal information from you This information includes details about how you interact with the app such as the areas you visit features you use and actions you perform We also collect information about your device including your location through your IP address and may receive some account information if you give permission for it to be shared This data is always collected in a way that is necessary and proportionate to provide the services you request and to improve the overall user experience

The personal data we collect is used for various important purposes First it helps us deliver and manage the core functions of the app such as scanning QR codes processing payments for subscription plans and managing your account and inquiries We also use this information to improve the app's security and prevent fraud unauthorized access and other illegal activities protecting both you and us

Furthermore we analyze aggregated and anonymized data about how the app is used to understand user behavior preferences and trends This allows us to continuously improve the design functionality and features of the app to better meet your needs We may also use your data to show advertisements relevant to your interests when you are browsing other websites or social media platforms however we never share your personal data for advertising purposes without your consent

We only share your personal data with trusted partners and service providers who help us operate the app and deliver our services These may include companies that assist with payment processing analytics security and customer support We ensure that all third parties receiving your data are bound by strict confidentiality and data protection obligations We may also share your data with legal authorities if required to comply with laws regulations or official investigations

Your personal data is retained only for as long as necessary to fulfill the purposes for which it was collected and to comply with any legal or regulatory requirements After this period your data is securely deleted or anonymized to prevent any unauthorized access or use

Protecting your privacy is very important to us We implement strong technical safeguards such as encryption secure servers and access controls as well as organizational measures including staff training and strict data handling policies to protect your information from loss misuse or unauthorized access We continuously review and improve our security practices to maintain a high level of protection

You have important rights regarding your personal data You can request access to the information we hold about you ask for corrections to any inaccurate data or request deletion of your data where applicable You also have the right to object to certain types of processing or to withdraw any consent you have given You can exercise these rights by contacting us directly and we will respond promptly and transparently to your requests

If you feel that your data protection rights have not been respected you have the option to lodge a complaint with the relevant data protection authorities We encourage you to reach out to us first so that we can address your concerns quickly and effectively
