- 1 Marching Band Parade Performance (minimum 50 performers)

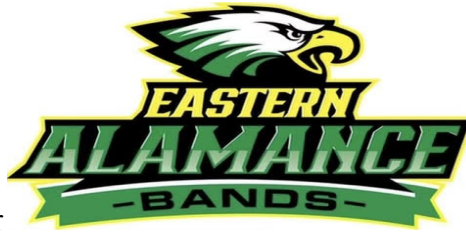
Current Schedule

Hotel Information: Walt Disney World Magic Music Resort

Student Eligibility: Traveling with the Marching Band is a *privilege*, not a right. In order to travel on this trip students must meet the following requirements:

1. No unexcused absences or tardies from performances. Any questions or potential conflicts must be communicated to Mr. Crotts prior to the first trip deposit due on May 31st, 2024. Mr. Crotts and Mrs. Simpson will determine if any absence is considered excused regarding trip eligibility.
2. Less than two unexcused tardies over the entire Marching Band season including all rehearsals
3. All fair share monies paid in full or waiver applied for
4. No disciplinary issues at any school/band events during the course of the school year. If we can not trust you within the confines of Eastern Alamance High School, then we can not be expected to trust you out of state for four days.

Any student who loses their trip eligibility due to not meeting the requirements listed above forfeit ALL money paid for their trip. No refunds will be given.

Payment Schedule Based on Quad Occupancy + Transportation = \$931:

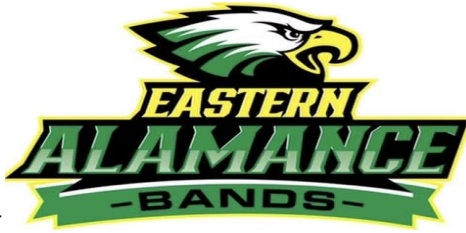
- \$100 Deposit Per Person due May 31, 2024 (Non-refundable)
- \$118 Per person payment due August 8, 2024
- \$118 Per person payment due September 5, 2024
- \$119 Per person due October 3, 2024
- \$119 Per person due November 7, 2024
- \$119 Per person due December 5, 2024
- \$119 Per person due January 9, 2025
- \$119 Final Balance due February 6, 2025

Current Cost at 4 people per room: \$931.00

(For Parents/Chaperones): Three to a Room: Additional \$76.00
Two to a Room: Additional \$182.00
One to a Room: Additional \$574.00
