Eisenhower High School Constitution and By Laws for Class of 2030

Article I - Membership

Section 1. This organization is a subsidiary of the Associated Student Body (ASB) of Eisenhower High School and as such has only powers as granted to them by charters and specific resolutions approved by the ASB.

Section 2. To be eligible for membership in this organization, a student must be a member of Eisenhower High Student Body and meet minimum eligibility requirements in academics (2.0).

Section 3. Membership eligibility in this organization shall also include: Must be an Eisenhower High School student who is expected to graduate in 2030.

Section 4. Seniors in active/good standing with the club will have the opportunity to purchase a graduation stole from the ASB Window. This stole will be embroidered with their name and the club they are currently active and in good standing with.

Article II - Officers

Section 1. The officers of this organization shall consist of a president, a treasurer, a secretary, and other officers as deemed necessary.

Section 2. Officers shall be elected at a regular meeting of the organization by a simple majority of the membership.

Section 3. If approved as an ASB Designee, the treasurer and advisor shall receive all funds immediately, turn them in to the Student Body Finance Clerk and shall keep an accurate account of receipts and disbursements in keeping with the policy for handling funds of school organizations.

Article III

Section 1. All meetings shall be open and shall be held under the supervision of the certificated advisor approved by the administration and the ASB.

Section 2. The activities of this organization shall be subject to the approval of the administration and the ASB.

Article IV - Meetings

Section 1. There shall be a regular meeting of this organization during the school year. Planning meetings for the Leadership Class will be held on **Mondays** each **week** at **11:58 AM - 12:18 PM** in **G-2**.
