SECTION A - READING SKILLS

I. Read the passage and answer the questions that follow.

Smoking-Injurious to Health

- 1. Smoking is the major cause of mortality with bronchogenic carcinoma of the lung and is one of the factors causing death due to malignancies of larynx, oral cavity, oesophagus, bladder, kidney, pancreas, stomach and uterine cervix and coronary heart diseases.
- 2. Nicotine is the major substance present in the smoke that causes physical dependence. The additives do produce damage to the body-for example, ammonia can result in a 100-fold increase in the ability of nicotine to enter into the smoke.
- 3. Levulinic acid, added to cigarettes to mask the harsh taste of the nicotine, can increase the binding of nicotine to brain receptors, which increases the kick of nicotine.
- 4. Smoke from the burning end of a cigarette contains over 4000 chemicals and 40 carcinogens. It has long been known that tobacco smoke is carcinogenic or cancer-causing.
- 5. The lungs of smokers collect an annual deposit of 1 to 1½ pounds of the gooey black material. Invisible gas phase of cigarette smoke contains nitrogen, oxygen and toxic gases like carbon monoxide, formaldehyde, acrolein, hydrogen cyanide and nitrogen oxides. These gases are poisonous and, in many cases interfere with the body's ability to transport oxygen.
- 6. Like many carcinogenic compounds, they can act as tumour promoters or tumour initiators by acting directly on the genetic make-up of cells of the body leading to development of cancer.
- 7. During smoking, within the first 8-10 seconds, nicotine is absorbed through the lungs and quickly moved into the bloodstream and circulated throughout the brain. Nicotine can also enter the bloodstream through the mucus membranes that line the mouth (if tobacco is chewed) or nose (if snuff is used) and even through the skin. Our brain is made up of billions of nerve cells. They communicate with each other by chemical messengers called neurotransmitters.
- 8. Nicotine is one of the most powerful nerve poisons and binds stereo-selectively to nicotinic receptors located in the brain, autonomic ganglia, the medulla, neuromuscular junctions. Located throughout the brain, they play a critical role in cognitive processes and memory.
- 9. The nicotine molecule is shaped like a neurotransmitter called acetylcholine which is involved in many functions including muscle movement, breathing, heart-rate, learning and memory. Nicotine, because of the similar structure with acetylcholine when it gets into the brain, attaches itself to acetylcholine sites and produces toxic effect.

Bank lockers have long been considered a safe option to store jewellery and important papers. However, in the recent past, there have been several instances of theft in bank lockers. Bank locker hiring agreements absolve banks of any responsibility for the losses. So, it may be prudent to insure the contents of the locker. Home insurance policies cover jewellery too, but you could also look at specific insurance for a bank locker. IFFCO-Tokio has recently launched a bank locker protection policy.

A locker insurance policy covers jewellery and other valuables kept in bank safes against accidents, burglary, acts of terrorism, among other things, but not cash. "Besides jewellery, important documents covered as an add-on feature," says Subrata Mondal, executive Vice- President (underwriting), IFFCCO-Tokio General Insurance. "The cost of replacing the lost or damaged documents is paid on an actual basis subject to a maximum sum insured of Rs. 25,000

BUYING THE POLICY

The policy is not available; it can be bought only through the branch offices of IFFCO-Tokio. In most cases, a self-declaration of the value of the jewellery suffices. However, if the value of an individual item exceeds Rs 10 lakh and the total sum assured is over Rs 40 lakh, then a valuation report from a government approved valuer is required.


CLAIM SETTLEMENT

For making a claim, you need to submit a copy of the First Information Report (FIR) filed by the bank along with the claim form. The claim is settled on the basis of the market value subject to the sum assured. Once the relevant documents are submitted, settlement takes in 15 days, says Mondal

COVER UNDER HOME INSURANCE

A few general insurance companies such as Bajaj Allianz also cover jewellery under home insurance, but generally there are sub limits to it, and you may not get a Rs 40 lakh cover for jewellery alone. "Under the My Home Insurance Policy, we cover not just the jewellery kept in homes but also in bank lockers," says Sasikumar Adidamu, Chief Technical Officer, Bajaj Allianz General Insurance. "The policy also offers worldwide coverage. So, the jewellery is covered even if a person is wearing/ carrying it anywhere in the world. A bank locker policy, on the other hand, does not cover jewellery kept at home or outside the bank

locker. Hence the premium paid for a bank locker policy is lower than that for insuring jewellery under home insurance.



SHOULD YOU BUY A SEPARATE LOCKER POLICY?

If the value of the contents in your locker is high and the premium low, it is prudent to cover the risk. The need to buy separate locker insurance depends on the intrinsic value of the locker contents and affordability the value is considerable a home insurance coverage not exhaustive
