# Order of Meta-Nihilist Independents

Freedom and Independence.

Two values, while different,

Inevitably reinforce one another.

Without Freedom, we cannot be independent,

And without Independence, we cannot be free.

From the Nihilistic English Order and Meta Independent Party gives birth the Order of Meta-Nihilist Independents (OMNI) which encapsulates the ideals of freedom and independence.

Registered voters who join OMNI wish 1) to remain neutral in gameplay philosophy while demonstrating serious engagement in the workings of the subreddit's governing system and 2) to engage in the dialogue of Freedom with noncommittal infrastructure that allows ideas to grow into something more. The OMNI party holds the following truths to be self-evident:

# With regards to the Constitution,

- 1. The Constitution is the Supreme Law of /r/democraciv and must be actively upheld.
- 2. The Constitution is to be determined by the letter of the law or, when the letter of the law is vague, by authorial intent (if available) or by the spirit of the law.
- 3. The Constitution shall be carefully protected, and unlawful modifications shall not be made.
- 4. The Voter Registry shall be carefully protected, and unlawful modifications shall not be made.
- 5. The Protectors of the Constitution must be held to a high standard, which can be traced by forming independent teams of archivists to remain vigilant for abuse to the document.

## With regards to the Moderation,

- 6. All citizens should act in compliance with all constitutional requests of the Moderation Team. Any obstruction of the Moderation Team shall be denounced by the Meta Independent Party.
- 7. The Moderation Team must be held to a high standard, regularly inspected for abuse of power, immediately tried for any credible suspicion of abuse, and granted a fair trial before recall.

# With regards to the Government,

8. OMNI will not endorse or denounce any proposed legislation, unless the proposed legislation is in unquestionable violation of the Constitution. All Meta Nihilists will be free to make their own decisions about supporting legislation.

- 9. OMNI will not endorse or denounce any proposed executive action, unless the action is in unquestionable violation of the Constitution. All Meta Nihilists will be free to make their own decisions about supporting these actions.
- 10. All government officials must be held to a high standard, regularly inspected for abuse of power, immediately tried for any credible suspicion of abuse, and granted a fair trial before recall.

## With regards to OMNI Members,

- 1. A member of OMNI shall be referred to as a Meta Nihilist.
- 2. All members of OMNI must be registered voters of /r/democraciv.
- 3. There are two subdivisions of the Order: OMNI Empire and OMNI Federation.
  - a. The OMNI Empire values Independence slightly more highly than Freedom.
  - b. The OMNI Federation value Freedom slightly more highly than Independence.
- 4. All Meta Nihilists must choose whether to join the OMNI Empire and become an "Imperial"; or join the OMNI Federation and become a "Federational".
- 5. Imperials who wish to run for Legislator will not run on the OMNI Legislative ticket, but instead will run on their own independent ticket.
- 6. Federationals who wish to run for Legislator will run on the OMNI Legislative ticket.

#### With regards to the OMNI Federation,

- 1. Federationals are not expected to pursue the party beliefs, and may construct and pursue their own beliefs and aims.
- 2. Because of this it is expected that sects will be formed and these sects will have full right to operate within and outside of the party lines.
- 3. Federationals generally follow in some forms Ethical Nihilism, Nihilism (Active & Passive), Hedonism, Libertarianism, and Defeatism. However these are not binding and are not required to be a member
- 4. Federationals are generally anti-authority in the sense that the belief that no God, King, or Person has the right to dictate over them, and that freedom is an ultimate and natural position of the Human spirit. However these beliefs are by no required, and although general are not total in envelopment.
- 5. Otherwise Federationals operate in many ways like members of any other party and have the full rights of the party behind them.

#### With regards to the OMNI Empire,

- 1. Imperials will only endorse judicial decisions that are in line with a fair, thorough, and valid interpretation of the Constitution.
- 2. Imperials will actively recruit and put forth qualified candidates to the judiciary. The Justices and Judges must swear to uphold the Constitution and to remain as nonpartisan as possible in making decisions. They also must hold credentials (either via degree, experience, or reputation)

- to back up their knowledge on the Constitution and their ability to interpret it in accordance with the Meta Independent Party's belief.
- 3. Imperials believe that delegating powers to lower courts in the judiciary is essential to the efficiency and effectiveness of the Judicial Branch, especially if the subreddit continues to grow.

# With regards to OMNI Leadership,

- 1. All significant actions to be taken by the party must be first approved through a democratic process in line with this Platform and overseen by the Party leaders.
- 2. The primary leader of OMNI shall be President of the Crown, who is charged with making sure the subreddit and the Discord server both are running smoothly.
  - a. The President of the Crown may appoint a Vice President, who shall proxy for the President if absent or take over fully if inactive for longer than a week.
- 3. The secondary leader of OMNI shall be President of the Commons, who is charged with making sure all votes are properly conducted and tallied.
  - a. The President of the Commons may appoint a Vice President, who shall proxy for the President if absent or take over fully if inactive for longer than a week.
- 4. The tertiary leader of OMNI shall be the Secretary, who is charged with engaging in recruiting efforts and keeping a list of members.
  - a. The Secretary may appoint a Vice Secretary, who shall proxy for the Secretary if absent or take over fully if inactive for longer than a week.
- 5. Should they be necessary, the ¾ of the higher leaders may appoint lower leaders called Managers to help with any duties of leadership. These managerial positions are defined by the higher leaders and can be formed or dissolved as needed.
- 6. If a leader is inactive, an active leader directly below them must fulfill that leader's duties.
- 7. On the first of January, April, July, and September, elections shall begin for a new President of the Crown, President of the Commons, and the Secretary.

#### With regards to the Crown,

- 1. The Crown shall be a person who keeps ownership of all OMNI vitals (the subreddit, Discord, member list, etc.) but has no power beyond the title.
- 2. The Crown may simultaneously serve as a Leader if they happen to be elected or appointed.
- 3. The Crown must select an heir who will take over if the Crown resigns or goes inactive. If no heir apparent exists, then the President of the Crown becomes the new Crown.
  - a. The Presidents and Secretary will vote if they believe the Crown can no longer serve.
- 4. The first Crown shall be /u/seekjaer, as he was the King of the Nihilistic English Order.

#### With regards to the Commons,

- 1. The Commons shall refer to all Meta Nihilists as a group.
- 2. When the Party wishes to perform a significant action, the President of the Commons shall call together the Commons to hold a vote.
- 3. Each member may vote yea, they may vote nay, or they may abstain.

4. All voting periods should be a minimum of 24 hours long, unless an emergency requires an expedited voting period, as determined by ¾ of the Higher Leadership.

# With regards to the Platform,

All Amendments to the OMNI Platform must be subjected to a 72-hour Party-wide vote. Each Party member may vote 'Yea', 'Nay', or 'Abstain' on a Proposed Amendment. The tallies shall not reflect members who fail to vote in the voting period. If the Yeas exceed the Nays and if the Abstains are one third or less of the total tally, then the Amendment shall go into effect. Otherwise, the Amendment fails but remains eligible for future votes.
