Subject: 2nd degree murder charges for prosecution of Derek Chauvin badge # 1087 and his partner Tou Thao #7162

Hello,

My name is **YOUR NAME AND WHERE YOU ARE FROM.** I am writing to you today on behalf of the George Floyd case, the murder of a Black man. I am calling for the prosecution of Derek Chauvin badge # 1087 and his partner Tou Thao #7162 to the fullest extent of the law. I also demand that the murder chargesof these offciers be raised. Both officers committed murder in the second degree and I, along with my peers will not rest until justice is served and proper charges are laid. George Floyd was arrested under an implied, non-violent crime. Bystanders of this incident state, as well as the video footage of this incident, show that Floyd did not resist arrest. Thus both officers, Chauvin and Thao used unnecessary force on the victim which is completely unacceptable and problematic in regards to the law.

In response to this recent tragedy, we demand immediate justice. Investigation of this case is not needed as it would only slow the prosecution time for the people responsible for taking a Black man's life. The evidence that is needed is already upfront and there in the murder video that is trending on social media. However, if Minneapolis police do resort to an investigation, I would like to ask you and your team how a murder, recorded in plain sight is investigated? What is there to investigate when the evidence is right there in front of you?

Additionally, it seems problematic to assume these officers are innocent until "proven" guilty as their efforts to end a man's life were again recorded on camera. So yes these officers were innocent until one decided to prevent a man from breathing by placing his neck on Geoge's neck and preventing him from breathing for 8 solid

minutes and the other chose to just stand there, ignoring Georges' cries for help. Thus there is no question about intention here because, one, how do you "accidentally" block someone's airway with your knee for 8 minutes and two, how do you ignore someone's cries for help or the voices of pedestrians to check the man's pulse. Likewise, in the video that is trending, you can clearly see how when local pedestrians insisted the officers check the man's pulse, both officers refused and did nothing. Upon the numerous times these pedestrians request a pulse check, officer Chauvin instead places his hands in his pockets while keeping his knee on the man's neck. Here the officer's body language and the face that he makes in the video insist that the officer somewhat enjoyed what he was doing, torturing and slowly taking the Black man's life away. This is enough to say that both officers had motive to take away a man's life and while this was not deliberate or planned, in the moment, while officer Chauvin failed to remove his knee for 8 minutes from Floyd's neck, he had the intention of ending this man's life and was well aware that this man could have died. Again, as a police officer whose duty is to ensure the safety for the public and civilians, it was his duty to make sure that Floyd was breathing. This itself is enough to account for murder in the second degree. This was not an accident. Please do use justice and call this what it is.

In response to the riots that are breaking out, there is evidence that many of these peaceful protests are turning into riots upon local police instigation. This here is what needs to be investigated. Not a murder that was recorded on camera.

Lastly, I would like to say that terrorism is not protesting police brutality but is rather killing innocent civilians, shooting at them with rubber bullets, and blocking their airways until they die. However, if you would like to argue that protesting can be done without violence then arrests can also be made without them turning into murder. It is now time to recognize the double standard that persists in society between white and Black people.

At this point, I would like to thank you for taking the time to read this and I hope to hear from you soon.

Subject: WITHDRAW Critical Infrastructure Defense Act

To Province of Alberta elected officials.

I, **YOUR NAME** am writing to you to express my concern about the Critical Infrastructure Defense Act.

In Section 2(c) of the Canadian Charter of Rights and Freedoms, the freedom of peaceful assembly is explicitly outlined. However, this act impedes on that right. In the bill, sidewalks and public roads (1.vii) are outlined as areas where "the obstruction and/or organization of obstruction" can be met with legal action. Peaceful protests in Canada and around the world have historically involved marching through streets and occupying sidewalks. Taking this opportunity away from peaceful activists by criminalizing it goes against our rights as Canadians. Furthermore, in section 5 of the bill, the definition of Critical Infrastructure is left to the discretion of the Lieutenant Governor in Council. By their nature, these sections can be used to stop peaceful protests.

Setting a dangerous precedent, this allows for citizens within their Canadian rights to be met with legal action and incarceration (without so much as a warrant). This letter is to call to attention the heavy reform needed on this Bill. It needs to be expressly declared that it will not impede on the rights of Albertan citizens to peacefully assemble. Otherwise, because of the aforementioned implications of the bill, it should not be passed.

I would strongly urge you to think about the moral and societal impact of signing this bill into effect on Friday and reconsider. Thank you for taking the time to listen to my concerns.



To whom it may concern,

I am writing today to express my outrage at Bill 1, also known as the Critical Infrastructure Defense Act. This Bill will undoubtedly limit the political freedoms of Albertans. Bill 1 not only infringes on our constitutional right to assemble and protest, it is in direct violation of section 2C of the Charter of Rights and Freedoms. I urge you to repeal Bill 1 and to use your power to advocate for the citizens of this province, and their right to protest and be heard.

Let's be clear, this Bill is decidedly not about trespassing; it is about suppressing dissenting voices. Regardless of political ideology, Bill 1 is a threat to all who choose to exercise their right to protest, because its punitive power can apply to almost any action in almost any space broadly designated to be 'critical infrastructure'. It's also important to point out that due to the documented prejudices of Canada's law enforcement agencies and judicial system, a bill such as this will disproportionately target and punish Indigenous (First Nations, Métis and Inuit) land and water defenders, Black people, and marginalized groups.

Will you remain silent and supportive of such a dangerous piece of legislation? Or will you stand up and defend my right to protest?

Bill 1, alongside the defunding of anti-racist grants and initiatives, not only creates barriers to the ways Albertans can pursue equity, justice, and human rights, but actively works against these principles. I fear that through Bill 1, the government will legally enforce the suppression of voices that urgently need to be heard. These two issues are only the latest in a string of UCP policies and budget cuts that draw a picture of a government more concerned with maintaining its own agenda than the well-being of its citizens.

My name is **_YOUR NAME**___ and I am emailing to demand the firing of Glenn De Caire from the position of head of Security Services at McMaster University.

McMaster's vague statement surrounding the Black Lives Matter protests uses Black Death as a PR stunt. If the university truly cared about Black students, you wouldn't have hired Glenn De Caire.

De Caire was the former chief of Hamilton Police Services and an ardent supporter of carding, and previously with Toronto Police Services for over 29 years. The Ontario Human Rights Commission has directly condemned his approach to policing as a "textbook description of racial profiling."

In Toronto, De Caire is best known for bringing surveillance cameras to Yonge Street and upgrading the Toronto police's computer system - both of which play a major role in TPS' targeting of racialized communities through an increase in surveillance and racial profiling.

De Caire is the creator of the ACTION police team, surrounded by scandal since its inception. ACTION teams patrol Hamilton's downtown neighbourhoods, pushing racialized and working class people out of the downtown core and making way for gentrification.

As reported by CBC Hamilton, "De Caire faced criticism this September [of 2015] after he forwarded an email to his front-line officers from a citizen who thanked officers for their service and said it's 'time for these black kids to stop blaming the police."

Moreover, "When the province opened the door for more widespread use of conducted energy weapons, or Tasers, among the front-line officers, Hamilton [Police Services under De Caire] was one of the first and most enthusiastic forces to respond."

In March of 2016, the MSU General Assembly passed a motion (86% in favour) to call on McMaster to terminate his contract. Students have clearly expressed that he is not wanted on campus. Yet, Glenn De Caire remains an employee of McMaster University.

McMaster's policing problem is more than just one face and one name. The Hamilton Police Services Board has the authority to approve McMaster Security Services procedures, and appoint "special constables." Hamilton Police Services and McMaster Security collaborate on training, use of force qualification, and patrolling - particularly during busy times of the school year. This has resulted in the invitation of ACTION police vans, horse mounted patrol units, public order and riot response teams, and HEAT officers to patrol campus and surrounding neighbourhoods. As McMaster expands, so does its policing and recruitment.

As such, I am demanding that Glenn De Caire is removed from his position as head of security.

Furthermore, I am demanding that all special constables are removed from campus, and that the university cut all ties with the Hamilton Police Services. These demands are put forward in the spirit of building a police and jail-free world. We will not accept any less.

Re: The murder of a 12-year-old schoolgirl, Shukri Yahya Abdi.

As your constituent, I am writing to call upon you to take action against Hazel Wood High School for concerning patterns of failures to protect both staff and pupils from bullying, resulting in deaths; and Greater Manchester Police for failing to properly investigate the murder of Shukri Abdi due to institutionalised racism. We demand justice for Shukri Abdi.

The body of Shukri, who first came to the UK in January 2017 as a refugee seeking a better life, was found in the River Irwell in Bury, Greater Manchester in June 2019. An inquest heard that Shukri had been threatened by her class peer/s and told: "if you don't get into the water, I'm going to kill you". I am utterly beyond outraged, saddened and disappointed that children in our society can be so badly let down and failed. Shukri has been described as an "angelic, funny and kind-hearted little girl" that had much to offer.

There are very concerning patterns of failure to meet adequate safeguarding measures at Hazel Wood High School, who has since rebranded from Broad Oak Sports College. The latest Ofsted report concluded that the school was "inadequate" and has thus since been put on "special measures" by Her Majesty's Chief Inspector, per section 44(1) of the Education Act 2005. Shukri has been woefully failed by Hazel Wood High School. Their incompetence can be argued to have played a key role in the murder of Shukri. Additionally, Manchester Evening News reported that in 2015 a "senior teacher, Caroline Bailey, at Broad Oak Sports College" (Hazel Wood High School) had committed suicide; an inquest heard that this was, yet again, due to "strategic bullying" from co-workers within the school. I urge you to raise these concerning patterns of failure to safeguard against bullying, resulting in deaths, at Hazel Wood High School, with the Secretary of State for Education, Gavin Williamson.

Furthermore, Greater Manchester Police (GMP) must also be investigated for their ineptitude in investigating this murder, no less a sign of institutionalised racism that has failed yet another black life. Reports show that the Officers at the scene of the murder took witness statements from only two out of four present at Shukri's death. Her murder was ruled by GMP to be an accident within two weeks. One can argue that Shukri's murder has not been properly investigated due to her ethnic background and, therefore, has led to my loss of confidence in the impartiality of the GMP in serving to protect and uphold justice for all citizens. I urge you to raise these concerns with the Mayor of Manchester, Andy Burnham.

Moreover, Shukri's death can also be placed in a wider landscape of institutional racism within modern-day Britain. Yvette Cooper, Labour MP and chair of the home affairs select committee damned the "deeply unfair shambles" of how asylum seekers are accommodated. The Guardian analysis of Home Office data found that "more than half of all asylum seekers (57%) housed by the government are done so in the poorest third of the country". I trust that we can agree that we must do more to support the most vulnerable in our society and that these statistics are wholly unacceptable.

As you are well aware of the global outrage against injustices rooted in systemic and perpetual institutionalised racism, I leave you with the words of human rights activist and organiser of the protests demanding justice for Shukri Abdi, Bashir Ibrahim: "she was failed when she was alive and she's still being failed now as she's dead". We demand justice for Shukri Abdi.

I am writing to you today to express my outrage regarding the Toronto Police Service budget of \$1.076 billion from the total \$13.5 billion 2020 operational budget for the City of Toronto (an increase of 4% since 2019). This astronomical police budget costs the taxpayer more than firefighters, paramedics, libraries and public housing combined. Following the recent horrific death of young Black and Indigenous woman Regis Korchinski-Paquet, I call upon our elected officials to ensure a transparent investigation into her death, beyond the SIU and start divesting from the systematically violent Toronto Police Service immediately.

Like thousands of people across the country, I was appalled to hear about Breonna Taylor's murder on March 13th. Echoing the requests of Louisville community organizers, the following demands must be met to ensure that the officers responsible for Breonna's death are held accountable for their brash, reprehensible

actions:

- 1. Your office and the Louisville City Council must address the use of force by the Louisville Metro Police
- 2. The officers that killed Breonna (Sgt. Jonathan Mattingly, Detective Brett Hankison, and Detective Myles Cosgrove) must be fired, and have their pensions revoked
- 3. Ensure that all necessary information is provided to a local, independent civilian community police accountability council
- 4. Create policy for a transparent investigation process due to law enforcement misconduct
- 5. Appoint a special prosecutor to bring forward charges against the officers and oversee all parts of this case

It is imperative that you condemn the actions of these officers. Raids cannot be performed with a shoot first, ask questions later mentality. Too many lives have been lost this way, and too often "danger" is determined by deeply entrenched racial biases, not actual threat level.

It is a tragedy that Breonna Taylor is not alive today. Police must be held to a higher standard than this. I trust that your office and the involved parties will do the right thing.

Dear Oklahoma Pardon and Parole Board and Governor Stitt.

Julius Jones (#270147OSP) is on Death Row for a horrific murder in 1999, despite persisting questions regarding his guilt. The ABC Network's three-hour documentary, The Last Defense, strengthens the case for his innocence. A worldwide audience is following the case. looking with fresh eyes at the Jones conviction, and concluding that he did not receive a fair trial. Due in part to legislation passed in the 1990s, appeals judges tend to review the specific evidence that is brought before them, and mostly avoid connecting the dots and evaluating how each mistake fits into the larger narrative. Former Florida Supreme Court Chief Justice Gerald Kogan wrote that the U. S. Supreme Court "should insist, at the very least, that Jones receives a hearing where all the evidence, including that of racial bias, can be heard." The Court ruled that these issues should have been raised earlier, therefore, Julius' life now depends upon Oklahomans, the Pardon and Parole Board and the governor. I ask that you grant clemency, so the quest for justice is no longer derailed. A diverse group of local and international leaders, including former House Speaker Kris Steele, the Congressional Black Caucus, Sister Helen Prejean, legal scholar Bryan Stevenson and others have joined the struggle for justice for Julius Jones. If Julius were retried today, what evidence could now be considered? The testimony of four family members on what Julius was doing at the time of the murder was not provided to the jury, neither did the jury hear statements by two inmates who said that the co-defendant bragged about the killing and the deal he made to get out of prison in 15 years. He, in fact, was released 15 years into his 30-year sentence. Julius' inexperienced public defender acknowledged that he did a "terrible job" of cross-examining the co-defendant who repeatedly contradicted himself when fingering Julius as the murderer. The only eyewitness testified that the shooter, like the co-defendant who had cornrows, had up to an inch of hair sticking out from his cap, but the jury wasn't shown contemporary photographs of Julius' close-cropped hair. A juror said, "Well, they should just take that n—out back, shoot him and bury him under the jail." The jury foreman told ABC that, in a case like that one, you "go with your heart more than anything else." The juror trusted "what you felt in your gut." When delivering the verdict, the juror "felt right." Oklahoma ranks first in the country's incarceration rates, and alarming cases of exonerations continue to persist because of the work of the Oklahoma Innocence Project. Because of the pervasive issues in Julius Jones' case, now is the time to review his clemency application and act affirmatively.

Are the police officers in the [City Police Department] being trained to de-escalate altercations by using peaceful conflict resolution strategies? Are the police officers in the [City Police Department] forbidden from using carotid restraints (chokeholds, strangleholds, etc.) and hog-tying methods? Furthermore, are they forbidden from transporting civilians in uncomfortable positions, such as face down in a vehicle?

Are the police officers in the [City Police Department] required to intervene if they witness another officer using excessive force? Will officers be reprimanded if they fail to intervene?

Are the police officers in the [City Police Department] forbidden from shooting at moving vehicles?

Is there a clear and enforced use-of-force continuum that details what weapons and force are acceptable in a wide variety of civilian-police interactions?

Are the officers in the [City Police Department] required to exhaust every other possible option before using excessive force?

Are the officers in the [City Police Department] required to give a verbal warning to civilians before drawing their weapon or using excessive

Are the officers in the [City Police Department] required to report each time they threaten to or use force on civilians?

force?

Are the officers in the [City Police Department] thoroughly vetted to ensure that they do not have a history with abuse, racism, xenophobia, homophobia / transphobia, or discrimination?

Are the officers in the [City Police Department] trained to perform and seek necessary medical action after using excessive force? Is there an early intervention system enforced to correct officers who use excessive force? Additionally, how many complaints does an officer have to receive before they are reprimanded? Before they are terminated? More than three complaints are unacceptable.

Statistics have indicated that by enforcing these policies, there is a significant decrease in civilian complaints and injury due to excessive force. If any of the policies are not currently in place, then what is being done to ensure that they are going to be enforced in the near future? What can I do, as a concerned citizen, to set these policies in motion?

I also want to increase the level of trust between the police department and the community. To establish trust, there has to be transparency. I would like to see the [City Police Department] collect and report data on civilian deaths that occurred in custody and as a result of an officer's use of excessive force. The data should be

broken down by demographics and should showcase the race, gender, sexuality, and religion of the civilians. Allowing the public access to this information will show us where we, as a community, fall short.

He has lived on death row for almost 20 years, is allowed one hour of sunlight a day, and three showers a week. He is suffering, and I ask for justice.

Mr. Jones was not adequately defended, as there was significant racial bias in the trial, and was failed by the very justice system this country is built on.

The original story claimed that Officer Delacruz used the Taser on her before she then used it on him to which he responded with a gun. However, there's no possible way Ms. Turner could have deployed this Taser, as it had not been reloaded. The use of Officers Delacruz's gun was completely unacceptable and completely unjustifiable.

Ms. Turner's family and friends are distraught. Not only was this major evidence withheld for a year, the Baytown Police Department and Officer Delacruz knew that Ms. Turner suffered from schizophrenia. A police department truly committed to community safety would have taken into account Ms. Turner's mental health struggles and opted for a peaceful arrest rather than one of violence and force.

Pamela Turner should be alive today. We appreciate that District Attorney Ogg will bring the case before a Grand Jury, but we ask for your commitment to recommend prosecution for Officer Delacruz.

In addition, I ask that we provide more support for the community's mental health and organizations that work to prevent police brutality and violence so nothing like this ever happens again. My name is [insert name]. I am a resident of [State/City], and I am emailing today to demand accountability for the racist murder of Tony McDade.

I am outraged about the May 27th killing of an unarmed black transgender man, Tony McDade, by Tallahassee Police Department. Tallahassee has a long history of racism, white supremacy, and transphobia and has seen three black people killed by police in under three months with no officer convictions, no official investigations,

and no actions taken by the TPD "Citizens Advisory Board", the State Attorney, Mayor John Dailey, or the City Commission.

This is not acceptable.

With the January 2020 appointment of Lawrence Revell as Police Chief, despite his killing of an unarmed black teenager named George Williams in 1996 and participation in the white supremacist Alpha Squad, I am concerned there will not be justice for Tony. I am urging you to do everything in your power to ensure a transparent and independent process in this case.

Less than three hours after Tony's murder, Chief Revell held a press conference stating he would not release the body camera footage of Tony's killing without being forced to do so. In that same press conference, Chief Revell and his officers blatantly and unapologetically misgendered Tony and lied about facts concerning the case. Contradicting the information given by TPD in the press conference Wednesday, eyewitness testimony and video footage of the shooting show that Tony was 1) unarmed, 2) shot 5-8 times in the back, and 3) that the officer was standing over Tony when the last shot was fired. The contradictions between the police reporting and the facts on the ground must be investigated and cleared up in a transparent process that gives the public a clear accounting of what actually happened.

Finally, this is a critical time in Tallahassee and these United States. A 2019 report by the National Center for Transgender Equality shows that police departments around the nation fail to serve and protect the rights of transgender people. What TPD is doing is even worse. TPD not only failed to protect and serve Tony, who was the victim of a trans-related hate crime attack the night before he died, they murdered him simply for being who he was.

I am requesting the following actions be taken:

- 1) the removal of Chief of Police Lawrence Revell from office,
- 2) open an unbiased investigation into the brutal murder of Tony McDade, arrest all the police officers involved, and release all body camera footage

3) that the TPD Citizens Advisory Committee be dissolved and replaced with a freely

elected Citizens Police Accountability Council

4)a public response from Mayor John Dailey, the City Commission, and the Mayor's

"LGBTQ Advisory Board" (all of which have been distinctly quiet) that outlines

specific actions they will be taking to address and overcome the racism and

transphobia currently widespread in the Tallahassee Police Department.

In addition, I ask that we start providing more support towards community efforts and

organizations outside of the police forces in order to prevent police brutality and

violence in the future. I also recognize the value of the work done by many of our

current law enforcement officers. I appreciate the sacrifices they and their families

make for the safety of our community, and I encourage you to include their input in

efforts to make safer, more restrictive use of force policies.
