# Clarifind Privacy Policy

At Clarifind ("Clarifind," "we," "us," or "our"), we are committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our mobile application ("App") and related services (collectively, the "Services").

By using our Services, you agree to the collection and use of your information in accordance with this policy.

#### Information We Collect

#### **Account Information**

- If you register as a guest, we will collect your nickname.
- If you sign up via a third-party social network (e.g., Facebook, Google), we may access your
  profile name, profile picture, and account ID for authentication. We do not store your social
  media passwords.

#### Usage Data

We automatically collect:

- Log Data: IP address, device type, operating system, interaction time, and clickstream data.
- Device Information: Device ID, MAC address, UDID (for personalized services).
- Location Data: Approximate location derived from your IP address.

#### **Payment Information**

- For in-app purchases, payments are processed by third-party providers (e.g., Google Play).
- We do not store credit card details. Payment processors adhere to PCI-DSS standards.

#### How We Use Your Information

We use collected data to:

- Provide, improve, and personalize the Services.
- Analyze usage trends and optimize performance.
- Deliver targeted ads (via encrypted identifiers).
- Comply with legal obligations.

#### **Sharing Your Information**

We may share data with:

- Service Providers: Third parties assisting with analytics, ads, or payments (e.g., Google Analytics).
- Legal Compliance: If required by law (e.g., subpoenas, fraud prevention).

• Social Networks: Only if you explicitly link your account.

We do not sell your personal data.

### **Data Security**

We implement safeguards (e.g., encryption) to protect your information. However, no method is 100% secure.

### **International Data Transfers**

Your data may be processed in the U.S. or other locations where privacy laws differ from your jurisdiction.

### Your Rights

- Access/Correct Data: Update account details in the App's "Mine."
- Delete Data: You can delete your account and associated data directly in the App's "Settings" page or request deletion via email:Service@clarifind.co.
- Opt-Out of Ads: Adjust device ad preferences (e.g., iOS Limit Ad Tracking).

### Children's Privacy

Our Services are not for users under 13. We do not knowingly collect data from children.
