By clicking "I have read and agree to the Legal and Safety Notice", you acknowledge that you have read, understood, and accepted all the terms and conditions set forth herein, and agree to comply with these rules.

## 1. License Statement

1.1 By submitting works to the Program, you authorize OpenELAB to display and share your submitted videos via the official website, social media, and other public channels for official publicity, branding, and promotion purposes.

1.2 OpenELAB will credit you as the creator with each use, unless otherwise agreed in writing by both parties.

## 2. Originality & Non-Infringement

2.1 All submitted works must be your original creations, and must not be plagiarized, copied, or infringe third-party intellectual property rights.

2.2 Any legal liability arising from infringement is solely borne by the submitter; OpenELAB reserves the right to cancel your participation or eligibility for awards.

## 3. Safety Compliance

3.1 All submissions must strictly abide by hardware and experiment safety standards. Deliberate damage, short-circuit, destruction of products, or demonstrating/performing any activity that threatens the safety of persons or property is strictly forbidden.

3.2 Any consequences from non-compliance with safety regulations shall be solely borne by the submitter.

## 4. Tax Responsibility

4.1 If you win prizes or receive rewards through your participation in the Program, all related taxes should be declared and paid in accordance with the laws and regulations of your country or region. OpenELAB will assist with necessary procedures as required.

## 5. Protection of Minors

5.1 If you are a minor, or if any minors appear in your video, you must obtain consent from their legal guardians and be able to provide supporting documentation upon request by OpenELAB.

5.2 You are solely responsible for any legal liability resulting from a failure to comply with applicable laws and regulations regarding the inclusion of minors in your content.
