At Arise Academy Speech + Debate, we hope to inspire Christian homeschool students to learn effective communication techniques among the safety of their peers and homeschool community. We believe that public speaking helps young students to break through barriers of self-doubt so they can build the confidence to face relational obstacles from their home to a wider society and become powerful vessels to change the world through the gospel of Jesus Christ.

# Club Location & Host Agreement

Arise Academy Speech + Debate operates under the jurisdiction of Arise Academy and Kalihi Union Church (2214 N King St, Honolulu, HI 96819), providing a safe Christian environment for student learning and growth. Arise Academy Speech + Debate operates as an extracurricular club, independent from Arise Academy Co-Op. Parents may or may not choose to utilize our club experience for academic credit. Course description is available on our website. See Credit Hour equivalents below.

#### **Credit Hours**

- **Speech Only:** 1 hour 25 min weekly = 39 hours, 40 min school year (3 credit hours)
- **Speech + Debate:** 3 hours weekly = 84 hour school year (5 credit hours)

Times are calculated based on a full year class over 28 weeks (August - May) including instructional time, practice time, and written assignment time at home.

### **PEOPLE & ROLES**

### **Student Eligibility**

#### Age Requirements

Students between 5 and 11 years old will participate in the Junior Speech program. Students between 12 and 18 years old are eligible for competition and will participate in the Senior Speech and / or Debate programs. Senior students must turn 12 by January 1st of the competition year in order to compete in that season of tournaments.

#### Family Requirements

Participating families must be practicing Christians and adhere and affirm the following statement of faith: <u>Nicene Creed</u>. We ask that families and students regularly attend a local Christian church and adhere to Christian ethical values.

### **Parent Volunteer Requirements**

Arise Academy Speech + Debate Club operates with essential parent volunteer support. One parent must be present throughout club time when their student is committed. Parents will rotate through various coaching and some will carry supervision roles throughout the year.

#### **Volunteer Expectations:**

- Speech coaching during club time breakout sessions (i.e., sign up for speech practice room to facilitate feedback process)
- Tournament judging and chaperoning. One adult 21 or older must be present for all 3 days of tournament. Adults may alternate as family schedule allows.
- Assist Club Leader with administrative support as needed (See Club Volunteer Roles)

# **CURRICULUM & TEACHING PLANS**

#### NCFCA Curriculum

Our club utilizes both the NCFCA Speech and Debate curriculum and the experience of past participants and community mentors. NCFCA's Comprehensive Guides to speech and debate support our mission statement and uniquely equip coaches and parents to teach students from a biblical worldview. We are proud to compete with NCFCA and will therefore train students toward the goal of competition each year.

The Club Leader and Parent Coaches may also supplement with other materials or have the freedom to create their own games and activities based on the needs of students. We work together as a community to meet the developing communication needs of our students and support families through their student's learning process.

# **Speech Events**

**Platform Speeches:** Students write, memorize, and present a speech on a self-selected topic (every student must compete with one Platform per year)

**Interpretation Speeches:** Students select literature and bring it to life with blocking and characterization.

**Limited Preparation Speeches:** Students prepare meaningful speeches on assigned topics within limited time.

#### **Debate Events**

<u>Policy Debate</u>: 2-on-2 debate centered around government policy.

<u>Value Debate</u>: 1-on-1 debate centered around values that drive decision making. (not currently offered at our club)

**Moot Court:** Simulated argument before an appellate court. (not currently offered at our club)

### ADMINISTRATIVE INFORMATION

#### **Club Fees**

- Mandatory Club Fee: \$80 per family (Deadline: July 31st)
- NCFCA Affiliation Fee: \$160 per family (Deadline: December 31st but encouraged to purchase ASAP)
  - Paid directly to NCFCA. Access to resources are not available until families pay affiliation fee
  - Junior-only families are only required to pay a non-affiliation fee of \$30 if their Junior will participate in Junior Tournament (optional)
- Curriculum: Every family must purchase the <u>NCFCA Speech Curriculum</u> (available through your affiliate dashboard in the NCFCA Shop) to have students complete assignments through the end of the school year and as a resource for speech definitions and techniques.
  - If curriculum has been purchased in a previous year, there is no need to purchase again. One set of curriculum may be used for multiple students in one family. Parents may also print multiple copies of the Student Workbook for individual assignments to be completed.

#### **Additional Costs**

- Apologetics: Evidence box and 3x5 or 4x6 cards, digital journal for research
- **Debate:** Folder storage box & notetaking supplies
- Extemporaneous: Laptop computer for research
- Tournament Attire: Professional suit and dress shoes (cost varies)
- NCFCA Instructional Workshops: As needed and available

# TOURNAMENT INVOLVEMENT

Tournament opportunities are available during the second semester, both online and in-person. Tournaments are the culminating goal for every student and what we train for in the first semester of each year. Our club requires competition because we believe (and have experienced) that healthy competition sharpens a student's efforts and motivation to improve themselves and provides an important opportunity for peer encouragement, development, and support.

### **Competition Requirements**

- Students must compete in at least one in-person qualifying tournament
- Competition in more than one tournament is optional depending on student/family goals
  - Every student must write and compete with one Platform Speech per year to fulfill research and evidence-based memorization practice
- Parent or adult chaperone of 21 years of age is required at all tournaments
  - Tournament participation runs from January through April (possibly June if student qualifies for Nationals)

### **Tournament Expectations**

- Students remain on tournament site from morning (appx 7:00 am) until evening (appx 9:30 pm) for three consecutive days.
- Parent chaperone must be present the entire time.
- Parents are expected to fulfill judging assignments throughout the tournament as needed.
- Families are expected to help recruit community judges for each tournament, including (but not limited to) participation in Judge Recruitment Ask-A-Thons.
- Professional dress code required for students (<u>detailed in NCFCA League Handbook</u>)

### **Registration Process**

Each parent and student involved in tournament must create a unique login through the NCFCA dashboard. Each family will be expected to:

- Check registration and check-in deadlines which are strictly enforced by NCFCA.
  Separate deadlines will include:
  - Event Registration
  - Tournament Payments
  - Meals
  - Script Submission
  - Check in before tournament begins

# STUDENT EXPECTATIONS

Students who commit to the NCFCA Arise Academy Club for the school year will be held to the following standards:

#### **Attendance**

Punctual and consistent attendance required

### **Academic Responsibilities**

- Develop speeches and debate cases/briefs as assigned
- Conduct research and memorization requirements
- Maintain work schedule for competitive preparation

### **Participation Standards**

- Active participation in club discussions and practice
- Provide constructive feedback in spirit of encouragement and support
- Observe and learn from other students' presentations
- Contribute to safe, encouraging learning environment

### **Competition Commitment**

- Compete in at least one qualifying tournament during Spring season
- Meet all tournament preparation deadlines
- Maintain professional behavior and appearance
- Represent Christ and club with integrity

### **Technology Policy**

- Turn in cell phones during club time unless instructed to use for judge recruitment or other club communication efforts
- Focus on communication skills without electronic distractions
- Use technology appropriately for research and preparation

#### **Dress Code**

- Adhere to NCFCA dress code emphasizing modesty and professionalism
- Follow Arise Academy campus guidelines
- Maintain professional appearance that respects yourself and others

#### **Christian Character**

- Come prepared to learn with a humble heart
- Treat everyone with utmost respect and love
- Use communication skills to glorify God
- Practice Colossians 4:6: "Let your speech always be gracious, seasoned with salt"

### LEADERSHIP PHILOSOPHY

Our chief goal is to build a safe community of communicators who love like Jesus. We believe NCFCA provides a framework where every young Christian can articulate their beliefs in a winsome way that glorifies God.

#### What Works Well

### **Motivation and Discipline**

Students thrive when they experience the creativity, bravery, and inspiration that comes from using their God-given voice in a trusted group of peers. Family involvement is key to student success as each develops communication skills.

# **GROUNDS FOR DISMISSAL**

We understand that life happens, and every family faces unique challenges and circumstances throughout the school year. Our heart is to work alongside families to help students succeed in their speech and debate journey. However, to maintain the integrity of our program and ensure the best learning environment for all students, there are times when difficult decisions must be made.

# When Dismissal May Be Considered

Lack of Participation in Discussion and Practice When a student consistently chooses not to engage in club discussions, practice sessions, or feedback opportunities, it impacts not only their own growth but also the learning environment for their peers. We recognize that some students need time to feel comfortable participating, and we are committed to providing encouragement and support.

**Poor Attendance** Regular attendance is essential for skill development and community building. While we understand that illness, family emergencies, and other circumstances arise, a pattern of frequent absences makes it difficult for students to progress and fully benefit from the program.

**Failure to Commit to Tournament Participation** Competing in at least one qualifying tournament is a core requirement of our program. We recognize that tournament participation

represents a significant commitment of time and resources for families, but this experience is essential for students to apply what they've learned and grow in confidence.

#### **Our Commitment to Communication**

Before any dismissal action is considered, we are committed to:

- Open dialogue with both parents and students about challenges being faced
- Understanding the root causes of difficulties and exploring solutions together
- Providing additional support and resources when possible
- Working collaboratively to address attendance, participation, or commitment concerns
- Offering grace periods for families experiencing temporary difficulties

#### The Dismissal Process

If concerns cannot be resolved through communication and support:

- Initial Discussion: The Club Leader will reach out for a conversation about specific concerns
- 2. Collaborative Problem-Solving: Together, we'll explore ways to address the challenges
- 3. Action Plan: If appropriate, we'll develop a plan with clear expectations and timeline
- 4. **Final Decision:** Only after exhausting supportive measures, a student may be asked to step away from club meetings for the remainder of the year

# **Looking Forward**

A dismissal from the current year does not reflect poorly on a student's character or future potential. We warmly invite families to consider rejoining the following year when circumstances may be different or when the student feels ready to fully engage with the program requirements.

# **Always Communicate**

**Please remember:** No family should struggle in silence. If you're facing challenges that might impact your student's participation, attendance, or tournament commitment, please reach out to the Club Leader immediately. We want to work with you, not against you. Many challenges can be addressed when we communicate openly and early.

Our goal is never to dismiss, but to help every student succeed. Communication is the key to making that happen.

# FREQUENTLY ASKED QUESTIONS

Will the Arise Club offer the same practice time as Honolulu Club? Each club allows for practice time based on the availability of space in the facility where that club is planted. Each club operates independently of each other and Club Leaders will make as much time as possible for each area of practice.

**How many coaches will there be?** While Club Leaders provide leadership and resources, parents will also train as on-site coaches and home coaches by being involved in club activities and learning strategies alongside their students. Experienced adults, students, and alumni also provide coaching support throughout the year.

**Will you grade student work?** In keeping with Arise Academy policy, final grading decisions remain with each family. Club leaders will provide suggested participation guidelines to help justify the educational experience.

Parents may use this grading guideline for final grading purposes according to Club Leader expectations:

- Attendance 20%
- Participation 20%
- Curriculum 20%
- Tournament Competition 40%

Can students participate with friends at Honolulu Club? Students may maintain friendships and practice with other clubs outside regular hours. Participation in multiple clubs requires payment of separate club fees for each. All clubs compete together at Qualifier and Regional tournaments.

Partnerships between clubs are limited to interpretive speeches and are highly discouraged for debate partnerships due to case load logistics and practice opportunities.
