THINGS TO NOTE:

- My TOS is public and attached to every invoice I send.
 - My TOS may receive occasional updates or clarifications.
 - By purchasing from me you agree to the terms and conditions below:

COMMISSIONS, CUSTOM DESIGNS, & CREDITING:

- My TAT varies, but art will be completed within three months or your money back.
 - Asking for updates on owed art is totally okay!
 - Completed commissions and designs are non-refundable.
 - I reserve the right to upload any and all art I make to my DeviantArt account.
 - My designs may not be sold for more than they were purchased for unless art is commissioned or created by the owner.
 - Refer to a species' TOS if redesigning, reselling, or rehoming.

 - Credit me whenever posting my art of your character(s) on any other sites.
 - Please credit me for my designs the first time you draw them.
 - Please also credit me for my designs on any reference sheets made for the character.
 - Crediting me is no longer required if the character goes through significant alterations.

PAYMENTS, HAGGLING, & HOLDS:

- USD payments may only be made through PayPal, Ko-fi, or Venmo.
- I accept game currencies/items in place of money (Flight Rising and Lorwolf).
- I accept DeviantArt points for characters who are valued at \$10 or less.
- Do not offer trades or art for characters unless they are listed as being for trade.
- Payments must be made within 48 hours of me accepting an offer.
- I will give ONE reminder to pay an invoice, sometimes extending the payment window slightly.
- Failure to pay will result in the cancellation of a commission or the re-opening of a slot/design.
- Ghosting will result in blocking.
- Retracting offers or canceling commissions due to unexpected bills/life events is fine, but please be communicative!
 - If you need to back out of a sale you paid a down payment on due to bills/life events, you are not eligible to receive that down payment back as it is non-refundable, but you will not be penalized for backing out of the character sale.
 - Backing out on a pending/held character multiple times will lead to blocking.
- I do not haggle on character prices unless there is a visible price range in the listing.
- Only make an offer within that range if applicable.
- I will hold characters valued under \$100 for up to two weeks, with a 50% non-refundable down payment.
- I will hold characters valued over \$100 for up to one month for every \$100 in value, not exceeding five months, with a 25% non-refundable down payment.
- I will hold characters with pending art payments for up to two months.

OTHER:

- None of my art/designs may be used to train AI or make NFTs.
- Do not take heavy inspiration from any of my designs.
- Do not send unsolicited link requests for any of my OCs.
- Do not ask for pings or offer on characters with the tags "DO NOT OFFER," "FOREVER HOMED," "NO PINGS," or "NFST"



GRAY LISTING:

Gray listed users will be blocked on a case-by-case basis. I will offer blocked gray listed users the opportunity to make amends and allow relaying of messages through proxies or side accounts.

You will be gray listed if:

- You are unnecessarily rude/hostile towards me.
 - You make me uncomfortable (case by case).

BLACKLISTING:

Blacklisted users will be blocked. A beware post may accompany the blacklisting, and you will be barred from owning any of my designs. Selling to blacklisted users will result in warning and/or blocking.

You will be blacklisted if:

- You attempt to scam me.
 - You fail to provide a refund for incomplete commissions.
 - You chargeback on any sold designs/commissions.

BLOCKING:

Most users I block have engaged in behaviors that I do not condone and will not be unblocked. I will offer users blocked due to ghosting or deleting sale/trade offers the opportunity to make amends and allow relaying of messages through proxies or side accounts.

You will be blocked if:

- You ghost me in regard to a held/pending character or invoice.
- You back out on a held/pending character twice.
- You delete a sale/trade offer I accepted.
- You engage in deplorable behaviors.
- You appear on my blacklist (*or my gray list, case-by-case*).
