Citation and reference writing uses the APA style. The text in the manuscript is written in the letters Callisto MT 11, justified, single space.

The introduction consists of the background, research / dedication / study objectives to be achieved, and if necessary it can describe the state of the art and theoretical discussion.

In this section, the authors describe the research methods, approaches and techniques used. If needed, the formula can be written using the help of "insert equation" in MS Word. In this section, the author does not need to describe the concept definition of the method used.
