INTRODUCTION

The manuscript is typed in 1 (one) space by using Ms. Word (Cambria font, size 10 pitch), with a minimum number of words ± 4000 words or 6-8 pages of A4 paper (including pictures, tables, illustrations, and bibliography), with typing limit, is left border = 3 cm, right border = 2.5 cm, upper limit = 2.5 cm, and lower limit = 2.5 cm

The introduction contains the **background of research problems (must be cited/quoted from previous journals / previous research), research context, methods used, literature review, novelty research, and research objectives. Use the MENDELEY Tools to perform citations.** All parts of the introduction are presented in an integrated manner in the form of paragraphs, with a length of 15-20% of the total length of the article.

References cited or cited use the APA 6th edition style, and please double-check with the bibliography (very helpful if you use the

bibliography facilities in a word processor that is integrated with Mendeley)

MATERIALS AND METHODS

Materials & methods contain explanations in paragraph format regarding **the research design, data sources, data collection techniques, datasets, and data analysis** which are carried out by researchers, with a length of 10-15% of the total length of the article. **No Need to Present THEORY.** All types of formulas are written using **Mathematical Equation** (for MS Word users in the Insert => Equation section), including division/fraction, Zigma, Root, Matrix, Integral, Limit / Log, Power, etc. **Don't Serve as a cropped image.**

RESULTS AND DISCUSSION

The research results section **contains a description of the analysis results related to the research question. Every research result should be discussed. The discussion contains the meaning of results and comparisons with theories and/or similar research results.** Length of exposure to yield and discussion of 40-60% of article length

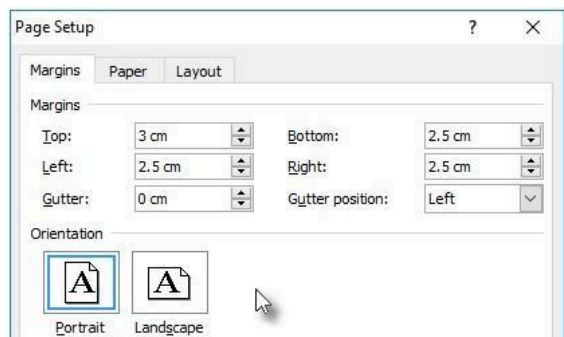

Every source and/or citation in your manuscript you must use Mendeley and must be in your list of references

Each table/figure, you must mention in your manuscript. The table is displayed by removing the vertical lines. The naming of tables or figures is **NOT ALLOWED** to use chapter numbers, such as Table H.1 or Table 2.1, and the like. Likewise, images are not allowed, like this: Figure 2.1. Image Name, or Figure H.2, and the like.

If you present a picture/table, you must mention the name of the image and mention the source of the image, as in the example of Figure 1.

References to images/tables from research results do not need to be included in the reference list, however, if images/tables are taken from other sources, those sources must be included in the Reference List.

CONCLUSION

The conclusions section contains research findings in the form of answers to research questions or the form of digest results of the discussion. **Conclusions are not allowed to repeat discussing problems or theory definitions.** Conclusions are presented in paragraph form. **Not presented in bullet points or numbering**

REFERENCE

The list of references contains only the sources referred to and all sources referred to must be listed in the list of references. The minimum number of references is 15 sources. **At least 80% of the reference sources are in the form of literature published in the last 5 years.** The references used are primary sources in the form of research articles in journals or research reports (including theses, theses, dissertations). Minimize book compilation. Articles published in the Journal of Educational Sciences are suggested to be used as a reference.
