#1 – AWARD CONTRACT FOR BID 01-06 [NEW AMBULANCE]

RESOLVED, that the City of Hornell Board of Public Safety hereby accepts the recommendation of Fire Chief Vince Kelly and awards the low bid for bid #01-06 to Jeff Blodgett of Tyler Fire Equipment of Canandaigua, for the purchase of a new 2006 MedTec ambulance at a cost of a \$113,700.

ON THE QUESTION:

Mayor Hogan noted the bids ranged from a low of \$113,700 to a high of \$124,619, and that Chief Kelly reviewed the bids. The Fire Chief recommended the low bid from Blodgett/Tyler Fire Equipment because "the MedTec ambulances are the ones we have been buying lately and we are very satisfied with [them]." Mayor Hogan asked Chief Kelly if he preferred to purchase the vehicle with cash in his account or to have a lease-purchase arrangement. Chief Kelly said he wanted to pay cash for this one and, if the second-ambulance option is exercised under this bid, possibly buying a second one through lease-purchase. The ambulance will be delivered 120 days from the date of a signed contract. Chief Kelly will provide the City Clerk with a copy of the signed contract for record keeping.

#2 – TRAFFIC ORDINANCE AMENDMENT – TIME-RESTRICTED PARKING ON CANISTEO STREET

NOW, THEREFORE, BE IT RESOLVED, ORDAINED AND ENACTED by the Board of Public Safety of the City of Hornell, N.Y., and the same hereby is resolved, ordained and enacted, that Article III, §300-20, §300-21, and §300-22, of the Traffic Ordinance of the City of Hornell, relating to Parking, Stopping and Standing in the City of Hornell, is hereby amended as follows:

1. "That Canisteo Street be restricted from STOPPING, STANDING OR PARKING along its easterly curb from the Southside Tavern parking lot entrance to the on-ramp for State Route 36, between the hours of 4 P.M. and 6 A.M."

This amendment is to take effect immediately and the same shall be published immediately.

ON THE OUESTION:

Mayor Hogan noted this traffic ordinance amendment is in response to concerns in the 10th Ward, particularly on Canisteo Street, regarding traffic congestion there at various times in the mid-afternoon to early evening due to pick-up and drop-off of dance studio participants. Police Chief Crowe and the police have studied the problems at various

times of the day and in conjunction with Mayor Hogan and Alderman John Carbone, a number of factors were considered, including the interests of businesses, residents and the traveling public, Mayor Hogan said. Restricting east-side parking overnight may or may not work, the Mayor said. "It is not a perfect solution and it is subject to change," he said. The Common Council and its Law & Ordinance Committee must also approve the traffic ordinance.
