○ Budget/Treasurer report

- *Attached are the Profit and Loss Statement, Balance Sheet Statement and the latest Bank Statement for the TCWCO. I have resent requests for payment for our Account Receivable items that are listed on the Balance Sheet. \$100 is still outstanding from MSVMA for the lunches provided to the adjudicators for the Solo & Ensemble and the renewal fee for the WMS for MSVMA. The IRS Form 1023 (Enrollment for Non-Profit Status) has been filed. If you think I should include a copy of the 1023 form, I can include this also. I have also filed the most recent Income Tax return (Form 990). I will be filing the prior years also in the upcoming weeks.*

- Committee reports
 - Social media-Angela Wiliford - Arranged to re-recognize ads/sponsors due to getting advertisement for only one concert last year. Posted on TCAPS social media, and reminded families to support these small businesses as much as possible.

- Scholarships - Looking for lead, Robin Keller volunteered to help. Subcommittee to create applications and roll out to the kids. Plans for the interview process to be included, which is good experience for the kids. Award can be used in any manner to enrich student music experience - for example may be used for vocal music camps.
- Uniforms (Natalie, Kami, Lauren S. - Subcommittee to meet and formulate plan for relocating to clear room for upcoming musical.
- Choir spirit (Sarah Newcomb) - Online store closed currently, but plans to reopen soon. Working on water bottle design.
- Booster rep (Tom H.) - Enjoyed the speaker, Mary Land, regarding the struggles of teaching at this challenging time.
 - Mini grant approvals - \$4000 awarded.
- Website (HT Snowday) - about to launch Google Suite
 - Tcwestchoirs.com (Check it out).
 - He is taking recommendations for prioritizing what aspect will be developed next.
 - Social media feed (reflects Facebook), though provides additional avenues for posting videos.
 - Choir lists to be clarified.
 - Link to store page.
 - Calendar links are updated.
 - Middle school program will be linked to website as well.
 - We are very close to non-profit status which allows free access to this service.
- Front of the House-(Lisa W.) - No report

- Mix and Mingle (M&M) - Still on hold . Timing is a consideration as we will need to coordinate with upcoming musical and potential upcoming middle school singa-thon.
 - Site/Location-Angela Wiliford
 - Silent auction- (not yet confirmed)
- Old business
 - Middle school did not participate in choir card sales, and no plans to fund raise until singathon which will be WMS focused.
 - Mr. Wangeman - outlined M&M and cabaret will be WSH focused events.
 - Heather SL reminded us money raised that is not related to our mission is taxable income.
- New business
 - Musical upcoming in March in some form or fashion - TBA.
 - Discuss Ads and Sponsors and where to go with it in consideration of covid times - Subcommittee report
 - Plan to run last year's ads again for upcoming events at smaller size.
 - Plans to roll out new sales after Christmas break - Due date 1/22/21 (soft deadline through 1/29/21).
 - Concern raised for selling ads at the beginning of the 2021, then looking ahead to turn around and sell again a few months later in the fall. It was noted that there is added value with posting ads on our social media. Considering the difficult economic times, sales may be

more challenging. Will proceed (later winter sale this school year and fall sale next year), and expect some businesses may opt out.

- Brochures are nearly ready for print deadline Monday.
- Will have some paper brochures, and a PDF file to share.
- Potential conflict issues through Youtube - Will not be able to post ads/sponsors here. Need to avoid monetizing on youtube or risk of being shut down. Dilemma would be solved by linking to our social media home page.
- Discussed setting up links to buy ad sponsorships w/ credit cards. Currently we don't have a credit card option for businesses to purchase ads. We are set-up only to buy/pay via check. Ideally would have "click here" to pay online. Group decided to continue status quo, and keep collecting via check this year. Hopefully can work through logistics and streamline this process for next year.
- Discussed upcoming booklet production and what to use in lieu of group photos.
 - Seniors have professional headshots that would work, though need to gather photos from underclassmen.
 - May use photographer that photographed choirs in the past
- Directors to consider updating bio.
