# AMENDMENT TO PAMARON MEADOWS SUBDIVISION DEVELOPMENT AGREEMENT TO ALLOW FOR DUPLEX UNITS

## STATUS/SALE OF PAMARON MEADOWS SUBDIVISION LOTS TO LSN CONSTRUCTION AND RUESCH COMPANIES

President Peter Mallek introduced Attorney Brian Formella to speak on behalf of the Village.

Brian Formella spoke saying the Village Board is agreeing to duplexes being built along with single family residences for the 15 remaining lots in Pamaron Subdivision. He recommends a written amendment (memorandum of understanding) be drafted and signed reaffirming the change from single family and add duplex language. He would like to see a definition of a duplex added to the amendment and the proposed sizes of duplexes. He stated that yes the Village agrees to duplexes being built but that the covenants, restrictions and liquidated damages will still be in effect. All of which is subject to all parties entering into an agreement of the amendment.

Ron Brock asked if the date of November 1 for the payment of liquidated damages could be extended or possibly not be part of the agreement since the builders have stated building could start immediately upon Village approval.

The board agreed to push back the date for the liquidated damages for 7 houses to be June 1<sup>st</sup>, 2024.

Craig Vitort **moved**, seconded by Alex Peden to push back the date of liquidated damages for 7 houses to June 1, 2024.
