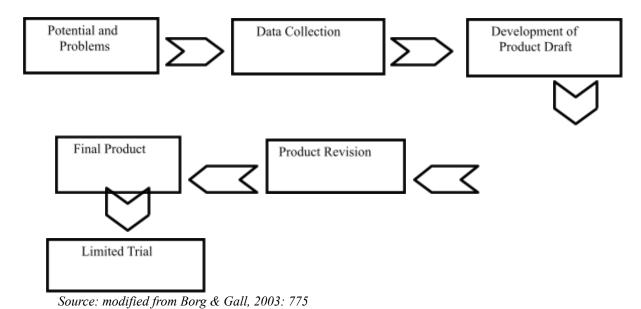


Figure 1. The Research and Development Stages of Performance Assessment-Based Authentic Assessment in Business Plan Subject
