

## **Operations**

On Behalf of the Operations Committee, I hereby move resolutions 1-

### 1. Preliminary 2024-2025 School Budget

BE IT RESOLVED, to introduce the preliminary 2024-2025 School Budget and authorize the School Business Administrator to submit the preliminary budget to the Warren County Office of Education for compliance and approval for advertisement in the NJ Herald as follows:

Budget Amounts: General Fund (11) \$12,066,650 Transfer to Charter School (10)\$13,273 Capital Expenditures (12) \$26,366 Special Revenue Fund (20) \$90,703 Debt Service (40) \$771,400 Total \$12,968,392

Taxation Amounts (School Fiscal Year) General Fund: \$10,203,923 Debt Service: \$708,290 Total Tax Levy \$10,912,213

The public hearing on the budget for the 2024-25 school year will be held at MVS on April 29, 2024 at 7:30 PM

## 2. Adjustment for Health Care Costs: \$62,783

BE IT RESOLVED that the Board of Education includes in the tentative budget the adjustment for increased costs of health benefits in the amount of \$62,783. The additional funds will be used to pay for the additional increases in health benefit premiums.

#### 3. Adjustment for Banked Cap: \$34,827

BE IT RESOLVED that the Board of Education includes in the tentative budget the adjustment for banked cap in the amount of \$34,827. In accordance with N.J.A.C. 6A:23A-10.3(b), the district has fully exhausted all eligible statutory spending authority. The adjustment will be used to/for generate revenue and fund balance. The Board of Education will complete this by June 30, 2025 and acknowledges that it cannot be deferred or incrementally completed over a longer period of time.
