

# Silver Team Race Seeding Event Sunday April 23, 2023 Seafarers Park Anacortes, WA



# **NOTICE OF RACE**

#### 1. RULES:

- 1.1. The regatta will be governed by the *rules* as defined in The Racing Rules of Sailing, the ISSA Procedural Rules, and the NWISA District Rules.
- 1.2. Under rule 70.5(a), the right of appeal is denied.
- 1.3. FJ class rules will not apply.

#### 2. ELIGIBILITY:

- 2.1. This is an Open Regatta as described in the NWISA District Rules. 'Active' and 'Mixed' teams may attend and compete as one fleet.
- 2.2. Teams shall comprise a minimum of 6 sailors.
- 2.3. This regatta is a seeding event for Silver Team Race Championships, the number of teams that will qualify will be determined and announced by the NWISA board prior to the event.
- 2.4. Teams shall be accompanied by a designated adult team leader, who may be an advisor, coach or parent recognized by the school.

#### 3. ENTRY AND ENTRY FEE:

- 3.1. All NWISA teams are encouraged to participate. If you need assistance with boats, with registration, or have questions about the regatta please contact the regatta host or district representative.
- 3.2. Eligible schools shall register through the NWISA website link. Registration is on a first come, first served basis if berths are limited. Registration opens April 10th at 1100.
- 3.3. Registration closes April 17th at 2200.
- 3.4. Teams unable to compete once registration closes, shall notify the regatta chair as soon as possible.
- 3.5. Each competitor must have a signed AWA waiver on file. Please complete a waiver for each competitor here: <a href="https://forms.gle/DaVzdWW5vV9b2YnX6">https://forms.gle/DaVzdWW5vV9b2YnX6</a>
- 3.6. An <u>entry fee of \$25</u> per team payable to: "Anacortes Waterfront Alliance" will be collected at check in. Teams can request to pay by credit card prior to the event.


#### 4. BOATS AND FORMAT:

- 4.1. This regatta will be sailed in FJs
- 4.2. The Anacortes Seahawks Sailing Team will provide 6 FJs to make up one flight for the regatta.

- **4.3.** Teams should plan to bring necessary boats to fill each additional flight. Please bring quality, team race colored sails for the regatta. Register all sail numbers and colors in the registration spreadsheet ASAP to avoid any duplicates.
- 4.4. the course for this regatta will be a Digital N

# 6. RACING AREA:

- **6.1.** All races will be sailed on Fidalgo Bay.
- **6.2.** Boat rotations will occur from floating docks at Seafarers Park.

## 7. TRAVEL AND TRANSPORTATION:

Teams are responsible for their own transportation. The address of the regatta site is: 601 Seafarers Way, Anacortes, WA 98221. A map of Anacortes and locations to view the race course is provided: Regatta Overview Map - Google Docs

#### 8. COACHING:

- 8.1. Team leaders, chaperones, coaches, parents, advisors, and other support personnel shall not go afloat in the sailing area from Saturday morning to the end of racing Sunday unless an exception has been explicitly permitted by the regatta chair. The penalty for failing to comply with this requirement may be the disqualification of all boats. competitors and teams associated with the infringing support personnel.
- 8.2. Competitors may receive coaching including instructions, assistance, equipment, or sustenance only while on the designated rotation float or on shore.
- 8.3. Race committee VHF channel 72

#### 9. DRONES

9.1. The use of drones is expressly prohibited, as stated in ISSA Procedural Rule 5.2.

#### 10. CONDUCT

- 10.1. No contestant shall use, either on or off the water, alcoholic beverages (beer, wine, or distilled spirits, each as defined in Chapter 51 of the US Internal Revenue Code and intended for beverage use), or marijuana, cocaine, or any other controlled substance (as defined in 21 US Code 802), the possession of which, by that contestant is unlawful under 21 US Code 841.
- 10.2. Infringements of this regulation and/or other inappropriate conduct occurring during the regatta, may be the basis for a hearing under RRS 69.1. The protest committee for such a hearing shall, at a time and place selected by it, meet to hear said protest, and it may impose scoring penalties, or other sanctions that it deems appropriate, including summary removal from the regatta.
