 - **1.** The Orioles program was a success. 96/150 students attended. I have all signed waivers and posted some pictures on the UMB instagram story make sure to follow us @umb_usga for updates on programming
 - a) Things to consider: next time on the communications I'll state more explicitly that students need a physical ticket to enter in to the game and I won't give student the option to meet me outside for tickets (I stood outside for nearly 3 hours, about 54 students came)
 - **2. Costume party** at <u>Choptank</u> in Fells Point <u>*OR*</u> at the school of nursing yard 10/31
 - **a)** Got a quote today from the manager there
 - **b)** Interested in using this space because its outdoors and spacious
 - c) Couldn't find a similarly situated black owned outdoor bar in Baltimore (if you know of one, please share!)
 - **d)** Capacity would likely be set at 100 and students would need to register through eventbrite
 - e) Person to incorporate a mask best into their costume gets prize; winner will be determined by senate E-Board
 - 3. Bengies Drive in Theatre 11/4
 - a) Got a quote from the owner. Will discuss this number with Ms. Rice, Treasurer and President
 - b) Movie cannot be selected until the Monday before the viewing
 - c) We would be renting an entire screen, so it'd just be UMB students (Covid- Conscious!)
 - **d)** Potentially thinking about getting a bus for students who don't drive; I'd ask them to bring blankets and maybe lawn chairs? IDK (open to suggestions here please)
 - e) Because of how pricey this program is, students interested in attending would need to pay a deposit of some sort. We can discuss what is reasonable, but I'd need confirmation of

attendance and the best way to do that is to require students to get some "skin in the game"

 - 2. For the committees that we need students reps for
 - **a)** Ask a peer in your school if they would like, they do not have to be a USGA senator

- A. Emilia Petrillo from the Student Counseling Center
 - 1. Feel free to reach out and get information or tour
 - **2.** Number of students utilizing during COVID not higher but still needed great work to connect students with resources in the community
 - 3. 8:30am to 5pm everyday
 - a) Initial eval needs to be during that time
 - **b)** Established students can schedule outside this time
 - c) You can walk in for assistance promptly
 - (1) Virtually walk in service
 - (a) Tele talk today
 - (i) Fill out form and submit
 - (ii) Before noon to see after 1pm
 - (2) simple/low key situation where you can see if you would like to get counseling
 - **d)** Crisis support line goes to the center while open and then there is a group that answers regardless of office hours
 - **4.** All information is confidential even if your school referred you
 - a) You have to put in writing if you want information given to anyone
 - **b)** 7 years after your last visit the information is deleted
 - 5. Mandated reporting when a person is a danger to themselves or others
 - **6.** Some challenges from last year had to due with finding providers off campus
 - a) Demand of mental health services has only increased
 - **b)** Stayed at student counseling longer but did find providers
 - (1) Sessions per student per period increased from 6 to 9 or 10
 - c) Had to increase outreach and prevention
 - **7.** Students from all schools visit
 - **a)** Some schools have approximately the same utilization per semester
 - **8.** Common situations that come in
 - a) Most people may not need outside services
 - (1) 10% of students present with mild to moderate symptoms
 - (2) See students regardless of mental health status
 - (a) Provide a bridge service and referral assistance
 - **b)** Consultation is NOT a commitment to continue services but students are welcome to come and check it out
 - 9. Call in to schedule a phone triage
 - a) 20-30 minute minute to get an idea what is going on, what needs are present, and
 - **b)** Come in for initial eval, about 45 min long
 - (1) With one of the counselors
 - (2) Needs, history talked about
 - (3) If more specialized care is needed, will be provided while looking students can still see counselors at the center
 - (4) Let the center know if you have financial difficulties to

cover services in the community there are partnerships to help

- **10.** Meet about every other week, no set session allotment but will assess with your provider
- **11.** "Consultants to the community"
 - a) Students can call in if they are concerned about a friend
 - **b)** Can request a tele talk to have the conversation too
 - c) Crisis line can help you with a friend in crisis too
 - (1) Can help you whatever time you need it
 - (2) They will let the university know if there is something that they need to do
- ${\bf B.}~$ Dr. Alvarez and Dr. Deck to speak KN95 mandate and any other student concerns
 - 1. Get your flu shot! Get with UMEC
 - **a)** Available in the SMC campus center on Wednesdays
 - **b)** HSHSL library is a location too
 - **2.** Booster shots for COVID for those who qualify are available at the student health center
 - a) As well as symptom free testing
 - 3. KN95 policy
 - a) Those without vaccine must wear KN95 at all times
 - **b)** People in classes/gatherings must wear as well
 - c) Food and drinks cannot be provided unless individually wrapped
 - 4. Space on the committee for student rep (Deck)
 - **5.** Questions about policy:
 - **a)** Working on planning a student open to talk about issues and concerns
 - **b)** Why KN95?
 - c) Are they safe?
 - d) Accessibility of masks (number of masks, ability to pay, etc)
 - e) Why is this policy in place?
 - (1) Good vaccination rate, location has steady positive rate since August
 - (2) Location high risk \rightarrow CDC guidelines to wear masks indoors
 - (3) Currently in steady 20 cases/100K in Baltimore city
 - **f)** Tool to give people to protect themselves from COVID with safety concerns of coming back to campus
 - **g)** Reason for KN95 is so that if someone in a class tests positive there should be the ability to maintain continuity in teaching in person without having to go remote while not having to quarantining other students (decreased risk of transmission) even though socially distancing
 - **h)** Difference between surgical masks and KN95. The cloth masks generally protect the other people, not the person who is wearing it.

- (1) KN95s are not certified by NIOSH(?) but are in other countries
- (2) *they do protect the wearer*
- i) Currently for IN the classrooms, not necessarily for other areas of the school
 - (1) DEPENDS likely on school

(a) Double check

- **j)** If you are in a setting where you are uncomfortable or worried about transmission then you should wear a KN95
- **k)** Fit test is not happening, however those who need a smaller mask, there are some ordered and available
- **I)** How long can you wear?
 - (1) Generally wear for 40 hours in "non high stress situations"(a) Not sweating, basic coverage
- **m)** Each school has been distributed masks and currently have 2/student

(1) Will have a second allocation for a total of 6 masks per student

n) Will there be a place to buy them on campus?

(1) Look into having them in the book store

- o) Enforcement?
 - (1) So far have been enforced
 - (2) Ethics Point is where you would go for reporting
 - (a) General guidance is to work as a community on the matter
- **p)** Contact UMEC and their physicians if you are concerned about your usage
- **q)** Dr. Alvarez will look into the campus bookstore stocking facemasks
- **r)** Everyone on campus should be getting masks regardless of whether or not they are on campus

(1) Numbers were based on campus vaccination rates

- s) Dr. Laura Cathcart
 - (1) Will a return to remote learning be a consideration
 - (a) Maybe if there is an increase in
 - breakthrough/severe cases or another variant
 - (i) Serious illness in vaccinated and breakthrough
 - (ii) Hope not to
- t) Current policies not reflected in Campus Groups?
 - (1) Gregory Brightbill is looking into this but feels it is present, just needs to make sure it is easily found
- **u)** University is aware of frustrations and is making these mandates in efforts to keep students safe and maintain current guidance under the CDC

- **v)** Can reach out to the COVID recovery email for questions or concerns

- **w)** There will be a KN95 infographic for when and where you will have to wear a KN95
 - (1) Requirement really for classrooms
 - (2) Otherwise on a voluntary basis
- x) How can we address anxiety about illness?

(1) Dr. Deck, Dr. Alvarez, school representatives, student counseling center, etc.

y) Feedback shared with senior leadership (the President's assistant (name?)) so that the university can help address these questions

C. OFR Funding Presentation: Project Feast

- Free Thanksgiving meal for those in the community (~30 years going)
 a) Grown to include donations
 - 2. Typically at Booker T. Washington School
 - 3. There will be COVID safety training
 - 4. No sit down area, food and donations will be individually packaged
 - **5.** Some logistics is still up in the air
 - a) Submitted to the SOM to get their approval
 - 6. Everyone would be masked with KN95, as socially distanced as possible
 - 7. USGA has been great in past years to add to the community effort that makes this event possible
 - 8. About 125 volunteers from 2019 that represented 4/7 schools
 - a) Collecting donations
 - **b)** Cooking turkeys
 - c) Etc.
 - **9.** Even if day of event volunteer numbers are decreased, hope to have more people leading up to the event
 - 10. Hope to give out COVID things (sanitizer, masks) and clothing
 - Money requested will cover primarily food and packaging materials, cooking materials and supplies
 - a) Asking for money for the building permit to be used for the cooking?
 - **12.** 800 meals were provided in 2019 and has a great impact on the community
 - 13. Question asked: Can you ask about the community engagement center?
