Acronym and Abbreviation Writing Rules

Define at First Use (Almost Always)

- **Acronyms and Abbreviations:** Spell out the full term at the first mention in the text, even if it is a very common one like "United States" (except for a few extremely well-known exceptions listed below). Immediately follow it with the abbreviation in parentheses. Example: "The Centers for Disease Control and Prevention (CDC) reported..." After this first definition, you can use the abbreviation throughout the rest of the paper.

Exceptions to the Define-at-First-Use Rule

- **Extremely Common Abbreviations:** A very small number of abbreviations are so universally understood that you don't need to define them. APA 7th edition specifically lists *only* these examples:
 - *et al.* (and others)
 - *i.e.* (that is)
 - *e.g.* (for example)
 - *cf.* (compare)
 - *viz.* (namely)
 - *vs.* (versus)
 - *etc.* (and so forth)
- **Units of Measurement:** Generally accepted units of measurement (like cm, kg, hr) do *not* need to be spelled out.

Consistency

After defining an abbreviation or acronym, use it consistently throughout. Do not switch back and forth between the full term and the abbreviated form.

Number of Uses

If an abbreviation or acronym is used only once or twice in the entire paper, it is usually better to spell out the full term each time, rather than defining it. The exception is if the abbreviation is required by a journal or publisher.

Plurals

- To make most acronyms plural, add a lowercase "s" *without* an apostrophe. Example: "CDCs."

Formatting

- Acronyms are typically written in all capital letters (e.g., APA, NASA).

In Tables and Figures

Good Corporate Governance and Earnings Management

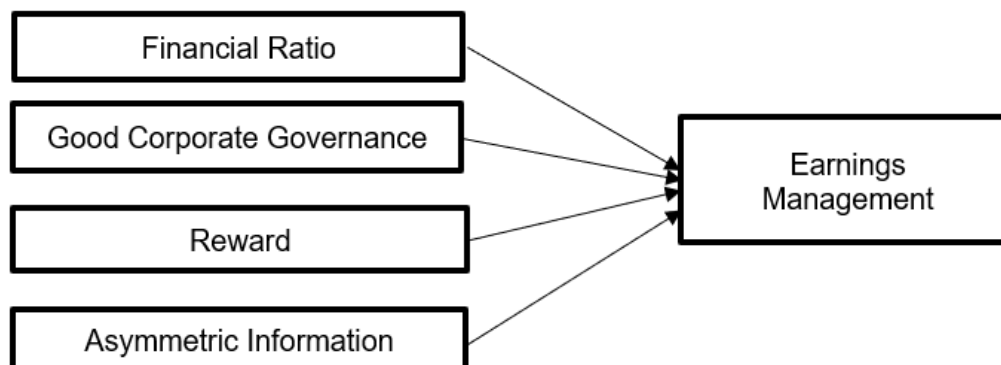
Effective corporate governance is essential for promoting financial transparency, accountability, and ethical business conduct, thereby reducing the risk of earnings management (Beasley, 1996; Klein, 2002). Firms with strong governance frameworks, such as independent boards, audit committees, and robust internal controls, are more likely to prevent managers from manipulating earnings (Xie, Davidson, & DaDalt, 2003). Research indicates that companies with well-established governance structures are less prone to earnings management, as these mechanisms enhance oversight and restrict managerial flexibility in financial reporting (Dechow, Sloan, & Sweeney, 1996). The Influence Between Financial Ratios and Earnings Management Practices

These findings align with the research by [Meilani and Widayastuti \(2022\)](#), which identified a positive relationship between profitability and earnings management. However, they contradict the findings of [Asri and Fauziati \(2022\)](#), who reported no significant relationship between profitability and earnings management.
