

Wedding Decor Rental Contract

This **Wedding Decor Rental Contract** is made effective as of **Aug 8, 2025**, by and between Sydney Rae Wedding Rentals, with a principal place of business located at [REDACTED] Hudsonville MI, 49426, and **CLIENT FULL NAME.**

1. Rental Agreement

1.1 Rental Items

The Company agrees to rent the following items to the Client for the wedding event scheduled on **Aug 8, 2025**:

- **LIST OF RENTED ITEMS AND PRICES**

1.2 Rental Period

The rental period shall commence 1-3 days before the date needed and shall end no later than 2 days after the commencement of the event.

2. Payment Terms

2.1 Deposit

A deposit of 50% of the total rental fee is due at the time of booking. The total rental fee is **DOLLAR AMOUNT**. The deposit amount is **DOLLAR AMOUNT**.

2.2 Final Payment

The remaining balance of 50% of the total rental fee is due at the time of pickup of the Rental Items. The remaining balance amount is **DOLLAR AMOUNT**.

3. Pickup/ Dropoff

3.1 Pickup Location

3.2 Drop Off Instructions

If no one is present at the pickup address, rental items must be slid under the garage door for dropoff.

4. Cleaning Fee

4.1 Cleaning Fee

A flat fee of **\$75.00** will be charged for any items returned dirty, regardless of rented amount. This fee may be paid prior to the rental date for those not intending to clean the items. This fee applies to any of the following:

- **Rental of Hurricane Vases**
- **Rental of Hurricane Shades**
- **Rental of Antique Dinner Plates**
- **Rental of Brass Candlesticks**

5. Condition of Rental Items

5.1 Inspection

The Client agrees to inspect all rental items upon pickup. Any discrepancies or damages must be reported to the company immediately.

5.2 Damaged or Missing Items

The Client shall be responsible for any damages or loss of Rental Items. The Client agrees to pay the predetermined replacement cost for any damaged or missing items. The replacement costs for items are as follows:

6. Cancellation Policy

6.1 Cancellation by Client

If the Client cancels the reservation more than 28 days before the Event, the Company will refund the deposit. If cancellation occurs within 28 days of the Event, the Client will be liable for the deposit and no refund will be issued.

6.2 Cancellation by Company

In the unlikely event that the Company must cancel the reservation, a full refund, including the deposit, will be provided to the Client.

7. Liability

Sydney Rae Wedding Rentals is not responsible for any damages, injuries, or losses incurred by the Client or any third parties resulting from the use of the Rental Items. The Client agrees to indemnify and hold harmless the Company from any claims, liabilities, or damages arising from the use of the Rental Items.

8. Governing Law

This Contract shall be governed by and construed in accordance with the laws of the State of Michigan.

9. Entire Agreement

This Contract constitutes the entire agreement between the parties and supersedes all prior agreements or understandings, whether written or oral, relating to the subject matter of this Contract.
