**Project: Enabling Mountainous and Rural Children from Five Provinces in Vietnam to Grow and Thrive (Short name: EM-THRIVE)**

### Background

The EM-THRIVE Project is Phase 4 of the Early Journey of Life Project (2014 – 2023) (<https://ejol.vn/>). EJOL is a parenting education program focusing on the first 1000 days of the child's life (from pregnancy to 24 months of age), promoting maternal physical and mental health and child development, and positive parenting skills through behavior-change training classes.

The EM-THRIVE Project will run for three years in 5 provinces of Ha Giang, Soc Trang, Quang Ninh, Binh Thuan and Can Tho. In collaboration with the Ministry of Health, National Expanded Program on Immunization, Provincial CDCs, and Provincial TV Stations, the project will adapt parenting education materials and videos from EJOL training programs into local dialects for pregnant women, parents of children from 0 to 5 and expand the training program's reach.

### Job Description

The M&E Officer will play a critical role in monitoring, evaluating on project progress. Key responsibilities include:

- Develop a comprehensive monitoring and evaluation plan based on the Project's Logical Framework and the overall project plan.
- Create and manage a system of M&E tools and indicators.
- Conduct training sessions for project staff and provincial officials on the M&E Toolkit
- Coordinate and implement field monitoring and evaluation activities.
- Provide technical support to provincial official during implementation.
- Manage project monitoring data and ensure proper documentation
- Coordinate with provincial officials to ensure timely submission of reports.
- Screen report data, provide feedback and compile findings for the Project Coordinator and Director.
- Analyze data to identify trends, recommend improvement measures, and assist with reporting.
- Support Project Coordinator and Director in evaluating the Project's effectiveness and impact.
- Perform other M&E tasks as required

### Qualifications and Requirements

- Bachelor's degree (Master's degree preferred) in public health, statistics or related fields.
- At least two years of experience in M&E roles for international projects in public health and community development.
- Experience in designing M&E tools and systems
- Strong skills in data analysis, management and reporting.

- Experience in field monitoring and training activities.
- Proficiency in statistical software (SPSS, STATA or R), and Real-time Monitoring Applications (Google Form, Kobo Toolbox, Tableau...)
- Fluently in English (spoken and written).
- Strong teamwork, work independently, problem solving, and organizational skills.
- Ability to work independently and travel to project sites across provinces.
