

Title is in 18-point TH Sarabun New (Center and Bold Text) on single line spacing.

(1 line-spacing)

Author Names (Use 16-point TH Sarabun New on single line spacing.

Begin with the first name of the author followed by the last name. For more than one author, type 'and' before the last author's name. For more than two authors, also separate each name by a comma (,). Identify each author's affiliation by superscript numbers at the end of the author's last name.)

Author Affiliations (Use 16-point Times New Roman font on single line spacing.

Include institutional and e-mail addresses for all authors. Place superscript number in front of author's affiliation corresponding to author's name.)

Abstract (16-point bold TH Sarabun New font on single line spacing)

For abstract content, use 16-point TH Sarabun New font on single line spacing. First line is indented 1.25 cm. An abstract of up to **200 words** must be included. Include your major findings in a useful and concise manner. Include a problem statement, objectives, brief methods, results, and the significance of your findings.

Keywords: List up 3-5 keywords and separate each keyword by a comma (,). The keywords should accurately reflect the content of the article. The keywords will be used for indexing purposes.

Introduction

Type text with 16-point TH Sarabun New font on single line spacing, with a 2.54 cm. top margin and 2.54 cm. margin for left, right and bottom. First lines of paragraphs are indented 1.25 cm. Please note that the paper size is standard A4 size. In MS Word, select “Page Layout” from the menu bar, and under Paper Size select A4 Size. Page number should be in the right side of the bottom.

The introduction should put the focus of the manuscript into a broader context. As you compose the introduction, think of readers who are not experts in this field. Include a brief review of the key literature. If there are relevant controversies or disagreements in the field, they should be mentioned so that a non-expert reader can find out about these issues further. The introduction should conclude with a brief statement of the overall aim of the experiments.

To insert a citation in the text, use the author-year system, i.e., the author’s last name and year of publication. Examples are as follows: "Since Johnson (2008) has shown that...(p.3)" or "This is in agreement with results obtained later (Benjamin, 2010, p.3)". In case of several page numbers, one can write "Since Johnson (2008) has shown that...(pp.3-10)". For 2-3 authors; all authors are to be listed, with “and” separating the last two authors, for more than three authors, list the first author followed by *et al.*

The list of references should be arranged alphabetically by authors' names. All publications cited in the text should be presented in a list of references following the text of the manuscript. The manuscript should be carefully checked to ensure that the spelling of authors' names and dates are the same in the text as in the reference list. Responsibility for the accuracy of bibliographic citations lies entirely with the author(s). Citation of a reference as "in press" implies that the item has been accepted for publication. Authors are responsible for the accuracy of the content of the references.

Body of Contents

First lines of paragraphs are indented 1.25 cm.

For tables, its captions must be aligned left. They should be produced in a spreadsheet program such as Microsoft Excel or in Microsoft Word. Type all text in tables using 16-point font on single line spacing. Type the caption above the table to the same width as the table. Tables should be numbered consecutively. Footnotes to tables should be typed below the table and should be referred to by superscript numbers. Tables should not duplicate results presented elsewhere in the manuscript (e.g., in graphs)

If figures are inserted into the main text, type figure captions below the figure. In addition, submit each figure individually as a separate file. Figures should be provided in a file format and resolution suitable for reproduction, e.g., EPS, JPEG or TIFF formats, without retouching. Photographs, charts, and diagrams should be referred to as "Figure(s)" and should be numbered consecutively in the order to which they are referred. At the under in each figures must have the reference "Reference:..." in the align left similar to the reference section.

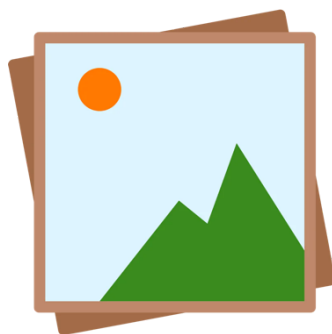


Figure 1 Figure caption

First lines of paragraphs are indented 1.25 cm. The Conclusion section restates the major findings and suggests further research.

References

First lines of paragraphs are indented 1.25 cm. HCU Conference proceedings uses the American Psychological Association (APA) referencing style, details of which can be found at <http://www.apastyle.org/>. References are arranged alphabetically according to the last names of the authors and then chronologically. The first line of each reference is aligned left. The following are examples of the APA referencing style (see also Purdue OWL APA Formatting and Style Guide from <https://owl.english.purdue.edu/owl/resource/560/01/>
