

Riley Gleason Memorial Scholarship Fund

Description:

The Riley Gleason Memorial Scholarship Fund was established in 2020 by the Woman's Life Insurance Society Chapter 814 of St. Clair, Mi as a memorial to former St. Clair High School student Riley Gleason. Riley was taken from this world on July 12, 2019.

The scholarship fund was established and is maintained by individual contributions and various fundraising projects of Woman's Life Chapter 814 and the matching donation of up to \$500 awarded from Woman's Life Insurance Society. The fund's objective is to provide an annual \$1,000.00 scholarship to a graduate of St. Clair High School who intends to enroll in community college, university or trade school. One scholarship will be awarded each year. The scholarship is intended for use toward tuition and/or books.

Scholarship applicants must:

- *Be graduating from St. Clair High School at the conclusion of the spring semester in the year in which the scholarship is considered and awarded.
- *Be active in school or community organizations.
- *Be enrolled or in the process of being enrolled full time or part time (a minimum of six credit hours) in an accredited institution of higher education. This school may include public or private university, community college or technical/trade school.
- *Must have a minimum high school GPA of 2.5 or higher
- *Must be a resident of the United States

The selection of the scholarship recipient will be made based on satisfactory academic achievement, extracurricular activities, and completion of all information requested in the scholarship application process. Awarded

scholarship stipends will be sent to the educational institution of the recipient's attendance to be held for use in his/her name for tuition and/or books. Recipients of the scholarship shall be selected by the Scholarship Evaluation Committee of the Woman's Life Insurance Society Chapter 814 based upon recommendations of the advising staff at St. Clair High School. All applications must be received no later than March 20 of the year in which the award is to be considered.

Please submit:

1. Completed application
2. High school transcript
3. Proof of Acceptance by higher learning institution and proof of Enrollment of at least six credit hours before the scholarship is paid.
4. A three hundred word essay on why you should be awarded this scholarship including any school or community activities or volunteer experiences that you have participated in or plan to participate in.
