#### Call to Order

### **SCC Meeting Debrief**

- **Voting:** The Chair of the Environmental Justice (EJ) Caucus spoke regarding voting acceptance at SCC meetings, which was well-received.
- **Signatures:** Colton mentioned signing for Matt Dobson, emphasizing the importance of allowing candidates to make their case.
- Legislative Outreach: Colton discussed an initiative to encourage members to write to state legislators regarding how the "Big Ugly Bill" has personally affected them. This idea was shared with Rep. Herndon and Matthew McQueen, receiving positive feedback.

- **Legislation Strategy:** The committee discussed the potential for drafting legislation or a "mock-up" bill to present to legislators regarding public power. Colton volunteered to help research and draft if that is the direction the coalition wants to take.

- Written Report: Colton emailed the written Caucus Report to Dan to be posted on the website alongside the YouTube video.
