Go—Sip operates independently of those websites and exists solely within the Chrome Extension environment.

## 2. User Accounts and Authentication

Authentication is managed exclusively through Google OAuth. By using Go—Sip, you authorize us to retrieve your name, email address, and profile picture from your Google account for the sole purpose of identity verification and comment attribution.

You are solely responsible for maintaining the confidentiality and integrity of your Google account credentials. We disclaim all liability arising from unauthorized access to your Go—Sip account due to third-party breaches of your Google account.

## 3. User Content and License

You may submit comments ("User Content") through the Extension interface. By submitting such content, you:

- Represent that the content is your original work and does not infringe on any third-party rights



- Grant Super Clear LTD a non-exclusive, worldwide, royalty-free license to store, display, and reproduce the content within the Go—Sip ecosystem

Super Clear LTD is not obligated to monitor User Content. However, we reserve the right (but not the obligation) to remove content, suspend accounts, or take any necessary action in cases of alleged abuse, illegality, or violation of these Terms.
