1. Purpose

The purpose of the WiN Global Innovative Leadership Award is to honour a person or organisation that has demonstrated strong commitment and outstanding innovative leadership skills, within the previous calendar year, beneficial for WiN Global development. This Award will promote and foster the development of innovative activities among WiN members. Enhancing leadership within organizations is the mainstay for organizational success. This award will help to cultivate the deep roots of innovative leadership among women in the nuclear field.

2. Objectives

- To recognise and reward the extraordinary work of individual professionals or organisations in supporting and advancing the WiN Global organisation.
- To increase the visibility and support of WiN Global and its vision, mission and objectives



3. Criteria and Candidates

To be considered as a viable candidate, a nominee must have demonstrated excellence in the following areas:

- **Communications** by communicating, with unwavering passion to evolve, inclusive attitude for various viewpoints, without excluding diverse ideas
- **Innovation** by proposing an innovative initiative, within the previous year, beneficial for WiN Global development
- **Leadership** by upholding the WiN Global vision, mission and objectives and growing the WiN Global into a future-oriented organization.

WiN Global members and non-members who meet the above criteria are eligible to be nominated.

The winner directly selected by a committee constituted by the WiN Global President, the WiN Global past Presidents and the WiN Global award committee chair

4. Award Schedule and Deadlines

The following schedule aligns with the confirmed date of the WiN Global Annual Conference (which is subject to variation depending on the hosting country) and the conference date will be confirmed to all WiN Global Executive and Board members.

6 months prior: WiN Global Awards Committee Chair will email all members of the WiN Global Executive and Board announcing the schedule for the annual WiN Global Honorary Award and asking for nominees for the award.

Details of the award (this document and application form) will be emailed (where an email address has been provided) to all WiN Global Executive and Board members for their information and use in submitting nominations. It will also be made available via the WiN Global website https://win-global.org/awards/Leadership.

4 months prior: Deadline for all submissions to be received by the WiN Global Awards Committee Chair. WiN Global Awards Committee Chair will announce the list of all nominees for the WiN Global Leadership Award to the WiN Global Executive and Board.

3 months prior: The winner will be directly selected by a committee constituted by the WiN Global President, the WiN Global past Presidents and the WiN Global award committee chair



2 months prior: WiN Global Awards Committee Chair will notify the successful candidate.

5. Documents to be submitted by Applicants

6. Prize

The successful candidate or organisation will be offered ONE free registration place at the WiN Global Conference and receive a framed certificate acknowledging them as the recipient of the WiN Global Innovative Leadership Award.

This will be presented at the WiN Global Annual Conference (where possible)

The winner of the Award will also be recognised in all WIN Global publications and communications (including on social media).

7. WiN Global Awards Committee

WiN Global has a dedicated Awards Committee who is responsible for managing and co-ordinating applications for all WiN Global Awards, including this award. The committee comprises a Chair and a minimum of three WiN Global Executives or Board Members (or their nominees). The winner of this award will be selected by a committee constituted by the WiN Global President, the WiN Global past Presidents and the WiN Global award committee chair

8. Terms and Conditions

- The award winner may not be nominated again in the future.
- Applicants not selected may re-apply for this award in the future.
- Nominees/Organisations may self-nominate or be nominated by a third party.
 In the case of the latter, the nominator must seek permission from the nominee to ensure they agree to the nomination.



- Winners must be willing and able to attend the upcoming
 WiN Global conference and the award ceremony where possible.
- Winners may be requested to be available for media and WiN Global outreach to share their experience about WiN Global and the award.
- By submitting their applications, candidates accept the Terms and Conditions of this WiN Global Innovative Leadership Award.
