Support social norming campaigns to prevent distracted driving, particularly among new drivers.	MV
Leverage existing mass media campaigns to promote caregiver help-seeking behaviors, as well as collaboration between businesses and policy makers to prevent child abuse (i.e. collective prosperity)	EfC CFPS
Educate businesses and policymakers about the effectiveness of family-friendly business practices in preventing child abuse and neglect.	EfC CFPS
Build public support for policies and programs that educate child welfare workers and other community-based agencies that work with families on safe storage practices for firearms, such as storing firearms unloaded, in a locked storage space, and separate from ammunition.	CFPS OSP
Leverage Statewide Mass Media Resources to promote awareness and social norming for parents and youth around following Colorado's Graduated Driver Licensing Laws for new drivers.	MV
