Part 2: Third-Party Privacy Disclaimer

LEGAL PRIVACY DISCLAIMER FOR INVESTIGATIVE MEDIA & PUBLIC ADVOCATES

1. **Redaction Protocol:** All documents and images contained within this public evidence folder have been checked for third-party privacy. The names, direct phone numbers, and private home addresses of innocent bystanders, lower-level court administrative staff, or unrelated witnesses have been explicitly redacted (blacked out).
2. **Public Interest Intent:** The dissemination of these records is driven entirely by an overwhelming public interest under Article 10 of the Human Rights Act (Freedom of Expression) to expose an active, illegal blockade on Article 6 (Right to a Fair Trial), severe **torture** Article 3 violation (Prohibition of Torture, Inhuman, or Degrading Treatment) and **breach of privacy** Article 8 violation (Right to Privacy).
3. **Use of Materials:** International investigative journalists and human rights organizations are granted full permission to download, mirror, reproduce, and cite these documents for the purposes of reporting on state accountability, judicial interference, and public sector misconduct.
