Thank you for taking time to read my T.O.S., please, be sure to agree with them before commissioning me. If there are any questions, feel free to contact me via Twitter or Bluesky DM (@leilielmeimiel) or Discord (@leimei_lm)!

General Information

- You have to be 18+ to commission me.
- I take both SFW and NSFW commissions.
- I reserve the right to decline the commission without disclosing my reasons.
- You agree that the commissioned artwork is for personal use only.
- I maintain the option to decide whether or not to share completed commissions on social media platforms.
- All copyrights for the artwork produced will remain with me, excluding the rights to the characters.
- The full price including all additional charges will be communicated with you before the start.
- Your commission will be finished within a month (unless otherwise specified).
 - Urgent commission (during a week) is possible by agreement for an extra charge
 see the "Payment and Pricing" section)

DOs and DONTs

- I DRAW:
 - SFW and NSFW;
 - o One, Two or Three characters together
 - Fanart and OC
 - o Human/Anthros
 - Any gender;
 - Any fandom (if I'm not familiar with the fandom I'll require some information about it, then, pls, describe your idea and the character (s) as detailed as possible);
 - o Light fetishes.
- I DON'T DRAW:

- Offensive or hateful material towards communities, cultures, genders and sexualities;
- Illegal material, such as depictions or implications of sexual abuse or underage characters or feral animals;
- Real people (celebrities, you & your friends);
- Extreme NSFW fetishes (non-con, gore, skat, etc).

Work process

- We exchange general notes about the idea, discuss references, after that I'll send a payment link.
- <u>Sketch.</u> After payment is received, I'll send out a rough sketch for approval. You can make adjustments if needed. Serious changes are only possible on this stage of work (1 iteration of edits is free, more than 1 will require additional payment).
- <u>Lineart</u> I'll send out a lineart preview (low rez image) after the sketch is approved and refined.
- <u>Flat color.</u> I'll send out a flat colored artwork preview (low rez image) for approval. Only very minor adjustments can be requested (i.g. changing color or tone of skin). (1 iteration of edits is free, more than 1 will require additional payment).
- Render. I'll send out a rendered artwork preview (low rez image). Only very minor adjustments can be requested.
- You receive the final commission (png format, min. 3500 pixels wide, 300 dpi) via link to download. You can use the image at your discretion but for personal use only. Also, my authorship must stay intact.
- Please, do not hesitate to ask me about progress on your commission or a WIP.
- Mistakes made by me like missing or getting a detail wrong do not count as changes and can be asked to be fixed any time, with the expectation of errors from insufficient references.

Distribution and Rights

- You agree that the commissioned artwork is for personal use only.
- You agree not to resell or use the commissioned artwork commercially in any form.
- I, the artist, retain all rights to my artwork and am free to edit, post, and display the artwork on my own websites and any other form I choose you can choose to remain anonymous or be tagged.
- If you don't want me to share your commissioned art please tell me beforehand or need an NDA, please specify ahead, it will also require extra charge please, see the "Payment and Pricing" section.
- You are free to post the commission within the rules of personal use (non-profitable usage):
 - o displaying the artwork online, in places of free access;

- o printing it for personal use.
- You are allowed to crop the art within a reason (e.g. icons, banners, profile pic ID, etc).
- You must always credit the author's name wherever you display it. You can do so by leaving a link to one of my sites or by stating my artist name (leilielmeimiel).
- You are not allowed to remove, blur or cover the watermark for whatever reason unless cropping the image for personal use within reason (see under distribution).
- Commissions of commercial use have their rights stated in the contract (profitable):
 - uploading/displaying the commissioned artwork in places of paid access;
 - o using the artwork as a mascot, for merchandise or as a logo;
 - o printing, publishing, redistributing.

Payment and Pricing

- The prices you can find in a price list (the pricelist refers to commissions for personal use only, prices for commercial commissions are discussed based on the project).
- Payments may be done both in EUR or USD.
- Payment schedule:
 - FOR commissions under 100\$: 100% advanced payment;
 - FOR commissions more than 100\$ split payment is possible: advanced payment after the commission confirmed, advanced payment after the lineart stage is approved.
- Additional costs:
 - o urgent commission will require an extra charge of 50% of total cost;
 - serious edits or the 2nd iteration of edits will require a fee, the total cost depends on difficulty.
 - NDA (private commission) will require an extra charge of 30% to the total cost.

Refunds

- Contact me for a refund.
- Refunds are possible but will have a deducted %, depending on the state of the commission. Once in flats stage payment might be rejected.
