It could be perhaps good to share how people approach the 'one shot' discussion of scholarly communication. This comment came up in a listserv overnight: "As a librarian, I need to be able to stand in front of a class of freshmen, to explain what peer-review is and why it's the gold standard for what they cite in their papers, and to be able to say it with a straight face without feeling like a liar. We do NOT have time to explain the intricacies of the scholarly publishing industry"

- Topic suggestion: Perhaps open access/open data and Indigenous data sovereignty
- Submission fees (not APCs) to journals that are covered by CAUL's R&P agreements. When we
 teach scholarly publication workshops, this practice is often highlighted as something a
 predatory journal would do and yet in the field of Accounting, Finance and Economics, many of
 the journals that are on the ABDC Dean's list (and covered under R&Ps) require a nonrefundable
 submission fee. I'd love to know if CAUL has a position on this or if it could be used as a
 negotiating point for better deals considering their 'triple dipping' practice. A great article

APO (Amanda) Susan McKinnon foundation taking over (link above) focus on supporting democracy, funding of research, think tanks etc

ALIA (Trish) Standards Australia MOU Dept Industry expired November - have not renewed, 6 month extension only - please update ALIA if any issues with license renewals, tech etc Orphan works scheme - push for collective license from industry (which we do not want) Reference group to advise attorney general around copyright and AI J of LIbrary and Information Association (green) - working group looking at its model right now send feedback to Trish. Possibility that it will flip.

Legislation: (Amanda) Online safety expectations aimed at large commercial corporations concern for wikipedia has lobbied to be outside of restrictions as non profit public sector. Age verification and issue of anonymity - would mean log in to read wikipedia, editors no longer anonymous. Looking for allies for submission Feb 16th deadline

National Science priorities - OAA submission (Ginny) disappointed with the draft, need national open science framework. Not clear when it will be released.

Submission on Towards responsible publishing cOAlititon S consultation process underway.

<u>Discussion of Poynder article -</u> open access movement has failed. As advocate how much do we engage with 'sealioning'? Timing of change - much inertia in the system we are changing will take time, celebrate the small victories along the way. Organisations like DORA have been possible because of the OA movement. Without the Open Access movement we also wouldn't have Open Educational Resources, Open Science and possibly Open Source software. Can't afford to be naive about the motivations of these global commercial corporations. Need to collaborate to have enough mass to resist these huge corporations. Pincer movement from grass roots and from above with policy legislations etc it was always going to be messy. The bit in the middle is very important - editors resigning, advocates talking to senior management etc. Power imbalance in favour of publishers was almost absolute 20 years ago,now there are options.

This historical point by Guedon is well made: "If Poynder were more of a historian, he would meditate on the fact that it took over 150 years to move from Gutenberg to the creation of gazettes: this shift entailed an entirely new perspective on the functions of document duplication- a shift from memory preservation to tracking news."

Need to collaborate bigger than any one institutions difficult when isolated geographically but must be in the forefront

Vigilant - publishers will come back with another strategy after every win (ACS for example)

CAUL: (Arthur) New negotiations 2024 full transparency will be emphasized at the very start as a precondition to agreements.

ACS want to respond individually to consortias - CAUL suggests a group meeting of all concerned. Placeholder for late January. Page where can sign support for the statements that have already been submitted.

Importance of hunting in packs, don't let them divide and conquer.

Lots of thoughtful discussions about the issues. We will be sending out a survey to all of those to participate in the events so we can begin thinking about next year.

Iftikhar Hayat - combined the Research Baazaar and OA week together. Played a game with all researchers, gave them artificial money to be used to read each article. Linked to R & P Agreements. We shared all of the sessions around the place for our associates.

Nicole Gammie: Very interesting presentation around OA textbooks and the metrics around those from a promotion viewpoint. Great to get info together to use as evidence for portions and gaining more funding and encouraging others to be a part of it. Please add link here.

Katya Henry: Wanted to share that we launched the CAUL NTRO Open Project, launched by Gary Pierce - here's a link to the recording & the LibGuide. CAUL FAIR and Open Non-Traditional Research Outputs Framework:

Gary Pearce - a logt of detailed research went into the development of the research, env scans & reported on that in the presentation. Fabulous help from CAUL & KH. Video & framework is there for people to look at and review.

Jayshree Mamtora: Thanks OAA for organising a fab series of webinars. Thank you for the recordings, we will be sharing them with our colleagues. We have had some activities & our OA awards since 2020 - each year bigger and better HDR & ECR & Open Education. Also a series of interview videos with researchers sharing their OA publishing strategies & will use the for our campaign across our institutions. Did have some drop ins. In the process of having OA ambassadors who can spread the OA word.

GB: cOAalition S proposal - after 5 years a new vision. Responsible publishing, trying to shake up the ecosystem moving toward something which is more academic led rather than publisher led. Survey, Consulting into next year. Large consultation because there was not too much 5 years ago. We will be putting some feedback in.

GB: I think it's good to see this sort of thing happening. NHMRC is a signatory to Plan S, and are interested observers of this, how much could they implement? Who knows?

Zac: Compelling proposal & delays around journal accepted version, good to see an ecosystem which is more holistic. Unis should get together and on board and get traction.

KH: CAUL is in discussion with the board about this.

Amanda Lawrence: Is it just about journal articles?

GB: All scholarly comms available in research assessment, and think it would be important to raise the inclusion of reports etc.

Paula: We were quite excited by the proposal, great to see funders being brave and at the moment the awards are being given by institutions, until they get on board it's going to be difficult for researchers to buy into in a big way.

GB: Agrees, you're right - the incentives are core to this, not just Journal articles. WE are all going in a similar direction.

Loretta: sounds quite interesting - we are revising our OA policy at the moment. Looking quite broadly and an Amanda Lawrence article about putting grey literature in repositories and also things such as online platforms such at The Conversation. APO announcement closing down. Still working on the draft - does anyone here in the community have advice on wording on this issue for their policy. I've not seen that sort of info included in policies.

KH: We had an inquiry at CAUL - reach out to connect with others via our email address.

GB: We do have an annex in the Plan S doc - if people have other models of academic publishing please include them in your responses.

Katya: New CoP Groups, this is a combined OASG & CC & CAUL groups. We have 64 people online - a resounding success so far. Putting out a call for co-convenors for this group and a repository sub-group and a diamond journal sub-group. We've had a couple of people put their hands up for the co-convenor role - EOIs are out please email Ginny, Janet or fill out this formKatya.https://docs.google.com/forms/d/e/1FAIpQLSdsQYYiaad4Ahhq_wm9FcL15FkkDukR_1JhPp9IotpM56rMb6g/viewform

Janet: FYI There are two reports which have come out. Knowledge Rights 21(copyright reform program) - one with SPARC on rights Retention, and one with Liber and are looking at secondary rights (ability to upload into a repository).

Katya: APO is closing down at Swinburne University just over a month to find a host institution and funding to continue (no luck with ANU talks). Amenada Lawrence to talk about the work APO does. Case study.

Amanda Lawrence: Haven't seen that case study. AL was the director of APO until end of 2018 - began in 2002 - idea was to bring together the reports and papers from research centers and NGOs and think tanks and other places. Reports, submissions, discussion papers. Always been a fantastic product in search of a business model. I'm still hopeful and having conversations with lots of people. Hoping that RMIT may consider taking on the hosting but it still needs to be discussed further. I was wondering about a crowdfunding campaign? Difficult

to explain and get funding for. Community doesn't understand the role - bread & butter of policy. In some ways its encouraging the amount of support its getting.

GB: I thought you put it well - it's a product with no model for being funded. Millions into NCRIS = 48 million into ARDC - astonishing.

AL: We've just been waiting NCRIS for 2 years to deliver on the roadmap.

Danny Kingsley: Greetings from a car outside Redcliffe Hospital. Anna Du Chesne OAI13 watch group. Friday 24 November - will send info out on this list.

Also - We thought it might be good to crowd source - if you see something that's good so we can find talks that you can get links to and tag. WE have a doc at the moment AuSCCoP Watch List (<u>Google Sheet</u>) of interesting and related talks.
