Pre-Payment Agreement

This Pre-Payment Discount Plan Agreement entered this ____ day of _____ 20__ by and between

Terms and Agreements:

Patient and Sports Edge Acupuncture, LLC, entered into a Pre-Payment Discount Agreement, and the patient agrees to make pre-payments using the terms provided below.

Description:

Pre-payment packages have been shown and explained thoroughly to the patient, and the patient clearly understands which plan suits his or her needs. For discounted fees to be effective, the patient must issue payment at the time of service (current day) and for services in the future. The patient has the right not to choose any packages and pay per service, in which case the regular fee of \$160/treatment will be charged (excluding consultation). The pre-payments are valid for up to six months from the original date of purchase.

Refund:

If there is a discontinuation of treatments and the patient does not complete their treatment plan, the patient may receive a refund. Refunds will be paid back no later than two weeks after the patient's request. However, the discounted price that the patient initially paid will be waived, and a higher charge will be imposed based on the number of treatments the patient completed. The discount was given in the first place because the patient committed to a group of treatments. By not completing the full pre-paid package, the patient forfeited his or her entitlement to the original discounted prices; the benefit will be lowered to the appropriate package levels.
