# Minutes of the monthly meeting of St Joseph's School Board of Trustees Held Tuesday, 10th August 2021, at 6.00 pm in Ruma Koru

# Welcome and Prayer:

Sharni welcomed everyone to the meeting. Victoria opened the meeting with a prayer.

# Property Upgrade:

The architects have supplied a draft plan for the building upgrade. Lorraine explained the financial side of the rebuild and what the priorities were. Due to the costs, the Junior buildings would not be getting an upgrade at this time although the heaters in the Junior block would be replaced with heat pumps. The Board discussed the pros and cons of the plans. The Board felt if the heaters were to be replaced in the Junior block, double glazing would be more feasible for retaining the heat. Lorraine to pass onto the Diocese the concerns of the Board along with their preferences.

### From the Pews:

The term has started well. The children have settled in well. There is light at the end of the tunnel for a rebuild which is long overdue. Very important to get the rebuild right. This is very important going forward.

# Principal's Report:

Goal 1: Ensure the future of our Catholic Community in North Otago by building a lifetime foundation in the Catholic faith, growing Catholic leaders, and promoting a Christ-centred community.

Surveys have been sent out to the Parish, students and Parents for the RE self-review. Looking at taking the Yr 6's and any parents who wish to come along, to St Kevin's to look at the new technology department. A concert is to be held at the Year 6 EOTC camp. Parents will receive an invitation to this. Incorporated in this will be a promotion of the Intermediate Department.

Goal 2: All students have meaningful and engaging experiences, striving for excellent outcomes for all.

There was an amazing celebration of Oral Language last term. This term the focus is on science.

We are experiencing an exceptional amount of movement in the Yr 4-6 at present. This is coursing a lot of unrest amongst the students. The students are unwilling to talk about their feelings. The Board discussed the behaviour of the children which is happening at present. Lorraine is applying for Limited Teaching Authority for our Teacher Aides to help relieve pressure on the teachers.

This is also on hold due to the lack of relievers at present. We hope to be able to complete this in Term 4. The budget is tracking on target.
