Privacy Policy

The Application is built by Maxis as a mobile application that is free for download. The Application is provided by Maxis at no cost and is intended for use as is. This page is used to inform visitors regarding Maxis' policy on the collection, usage, and disclosure of personal information when you use our Service. The Maxis' Privacy Statement shall also form an integral part of this Privacy Policy.

If you choose to use our Service, then you agree to the collection and use of information in relation to this Privacy Policy and the Maxis' Privacy Statement. The personal information that we collect is used for providing and improving the Service. We will not use or share your information with anyone except as described in this Privacy Policy.

Unless otherwise defined in this Privacy Policy, the terms used in this Privacy Policy have the same meanings as in our Maxis Terms and Conditions.

INFORMATION COLLECTION AND USE

For a better experience, while using our Service, we may require you to provide us with certain personally identifiable information. The information we requested will be used as described in this Privacy Policy. In your usage of the Service, you will be providing us and we will be collecting the following information:

- Your email address to register for an account.
- Profile information to set up your user profile (e.g., name, picture).
- Content belonging to or created by you (e.g., photos, videos, audio notes, and other materials) that you post/upload to the Application ("User Content").
- Communications between you and Maxis. For example, we may send you
 Service-related emails (e.g., account verification, changes/updates to features of the
 Service, technical and security notices). Note that you may opt out of Service-related
 emails.

The information that we requested in your use of our Service will be used as described in this Privacy Policy. Usage information:

 We collect information relating to how you use the Service, including actions you take in your Application account (such as sharing, editing, viewing, creating and deleting content). We use this information to provide, improve and promote our Service.

Analytics information:

 We use third-party analytics tools to help us measure traffic and usage trends for the Service. These tools collect information sent by your device or our Service, including the web pages you visit, add-ons, and other information that assists us in improving the Service. We collect and use this analytics information with analytics information from other users of the Application ("Users") so that it cannot reasonably be used to identify any particular individual user.

Device identifiers:

When you use a mobile device like a tablet or phone to access our Service, we may
