## Health Guarantee and Sales Contract

Breeder/seller & the buyer agree as follows: Said puppy is to be secured by buyer by placing a Nonrefundable deposit of \$\_\_\_\_\_ known as Surety of Action, which is applied to the Purchase price. The buyer is purchasing said Boston Terrier puppy from the breeder/seller for \$\_\_\_\_\_. Which is to be paid in full by the time the puppy is 6 weeks old. Buyer may not obtain possession of said puppy until 8 weeks of age.

All precautions have been made to ensure that puppy is in excellent health at the time of purchase and possession. The breeder guarantees that this puppy is free from hereditary defects to the best of their knowledge. Puppy is guaranteed to be JHC Clear (juvenile hereditary cataracts) & DM unaffected (degenerative myelopathy) which causes spinal paralysis in the rear end. This 1-year guarantee applies to original purchaser only and is not transferable. Buyer needs to be aware that this puppy is a baby and that it is possible for him/her to get sick due to stress or other related reasons. He/she is leaving her only known home and family and entering a new environment. Stress related illness is possible. It is the buyer's responsibility to ensure said puppy gets proper rest and reassurance that they are safe. It is the buyer's responsibility to prevent illness and injury by providing necessary booster vaccines, veterinary care, nutritious food, fresh water, appropriate indoor shelter, and supervision. Breeder does not assume any responsibility or liability for injury or neglect after picking up. The breeder is not liable & won't be held responsible for any bills pertaining to this puppy/dog once the buyer obtains ownership (puppy/dog leaves breeders' premises) The breeder has made every effort to breed healthy dogs and has raised this puppy with love and care and is entrusting buyer to continue the same. Breeder is not liable for any internal or external parasites including but not limited to coccidia and giardia. These are common and can easily be acquired at any time. Puppies may be severely stressed by a change of environment. Minor problems such as Diarrhea, Kennel cough, Coccidiosis, Giardia, Worms, etc. are common and must be treated. These conditions are the responsibility of the Buyer & should be checked by a licensed veterinarian & treated. Minor health problems that can be cured by medication are not covered by any guarantee Diligent Precautions have been taken and to the best of this breeder's knowledge this puppy is free of any parasites. Cherry eye, & stenotic nares are NOT covered under this guarantee as they are common in brachycephalic breeds. Undescended testicles, hernias and non-hereditary cosmetic issues are NOT covered. Again, breeder makes every effort to ensure that dogs with these issues, are not used and bred in their lines.

There are certain disorders that may be caused by environmental factors which include but are not limited to: Allergies, thyroid dysfunction, demodectic mange, cancer, tumors, growths, scabies, mites, & other auto immune disorders which are not covered. ALL puppies will come with a signed veterinarian health examination report, age-appropriate vaccines, deworming up to date, and free from obvious defects at time of pick up. If a veterinarian finds said puppy to be unhealthy or have a life threatening or serious genetic defect, a statement in writing must be provided by that veterinarian documenting said condition for the breeder's veterinarian to review. If veterinarians disagree, a report from a third unassociated veterinarian stating the same results will be required. If two of the three veterinarians concur, Buyer may return puppy, along with registration, and all the puppy's effects to the breeder for

another comparable puppy of the same gender if available, (agreed upon by both parties, \*note\* replacement puppy may not be from the same parents as original puppy) or a full refund. Buyer is responsible for all transportation costs of puppies.

***Buyer agrees that puppy will not be used for breeding purposes unless breeding rights have been included in price and are indicated on the new puppy registration.***

Buyer will maintain said puppy in an appropriate and human environment, and properly train, housebreak, and care for (quality food, appropriate shelter, and veterinarian care) said puppy. The dog will be properly licensed and inoculated against Rabies, Distemper, Parvo, and any communicable diseases recommended by a qualified veterinarian. In the event of any legal action being necessary to enforce Any part of this Contract by either party, all proceedings will take place in the state and county in which the breeder resides and will be paid for by the party at fault by the requirements of this contract.
