<u>Superintendent Report</u> – Matt Foster was present to highlight a few items.

Staff development training – grant funded. Training around the MTSS framework.

Wellness fair – Twinfield will host the first one.

Principal's Report – some points highlighted

A group of students out on a walk, stepped on an underground bee's nest. Everyone is ok. Have not been able to identify yet where the underground nest is.

PBIS celebrations have taken place.

Went over major and minor behaviors tracked to date.

Afterschool program is on schedule. Clubs will be within the next week.

Student Services Report – no discussion

Director of HR Michael Fredieu – introduced himself to the board and shared his background.

<u>Denmark Exchange</u> – Chris Sheehan was present to share a presentation.

Democracy exchange project with Denmark.

8 students will be going. Jeff Eddy and Chris Sheehan will go on the trip. Jeff will only go for one of the two weeks. The estimated total for the trip is around \$15,000. \$6200 - \$8000 expected from students. At this point they need to find around \$8,500 from fundraising and the school. Then the Denmark students will come here to be hosted.

<u>CIP – Continuous Improvement Plan</u> (Patti Sprague)

Patti shared the 3 main goals and the assessment growth.

Twinfield's Academic Goal -

By June 2026 100% of all students K-12 will show at least a year's worth of growth.

Twinfield's Safe and Healthy Schools Goal -

Absenteeism – shared Twinfield's percentage of chronic absenteeism. Decrease chronic absenteeism by 50%.

Twinfield receives a little over \$200k in title funds.

A **motion** to approve the Twinfield goals noted above by Patrick Healy and seconded by Janna Osman. Motion passed.

Open House is Wednesday, September 17 at 4:30 pm.

Sara wondered if the school has been posting updates and events on Facebook? Everything needs to be on Facebook and the Front Porch Forum.

Principals are working to make sure all parents are signed up for Parent Square.

She is an Administrative Asst at the school and loves the school and the community.
