Dear Parent or Guardian,

The Seventh Grade Teachers have put together a phenomenal Charleston, SC trip this year that will provide both educational and cultural experiences enriching our 7th grade curriculum. Please carefully read the following information.

WHERE

Seventh grade students will be taking a two day/one-night trip to Charleston, SC. The cost of the trip will be approximately \$382, depending on the number of students who attend. The total amount for the trip will be revised based on the number of students attending.

WHO

All 7th grade students who conduct themselves appropriately according to school rules throughout the school year are eligible.

WHEN

The group will depart the morning of Thursday, April 29, 2027, and will return the evening of Friday, April 30, 2027. Students will need transportation to arrive at school by 5:45 AM on Thursday and will need to be picked up after regular hours on Friday. Students must attend the entire trip from departure to arrival. No early parent pick-up is permitted.

WHAT IS INCLUDED?

Charter bus transportation, 1-night hotel accommodations with security, tour guides, admissions to attractions, and meals are included in the price. Souvenirs are not included.

PAYMENTS

The total cost of the trip is \$382. The permission slip is due October 2, 2026 and the first payment (deposit) of \$120 is due on or before October 16, 2026. **The deposit is NON-REFUNDABLE.** All payments for this trip will be made directly to Emerald Student Travel. Northwest Cabarrus Middle School will not be collecting money for this trip. Payments will be collected via an online website. The link to the payment website can be found on the school webpage. The payment schedule is listed below.

Payment Schedule

October 16, 2026	\$120 non-refundable deposit
November 13, 2026	\$120
March 12, 2027	\$142 - final payment will be revised based on the number of students attending

You may pay the balance in full at any time, but the first \$120 non-refundable deposit MUST be paid by October 16, 2026, in order to secure your child a spot on the trip. Exceptions to this will be made only for students who enroll at our school after October 16, 2026.

Any student who owes money to the cafeteria, WILL NOT be able to attend the Charleston, SC trip.

REFUNDS

Students who are disqualified or unable to go will lose **all or part** of the money for the trip as the cost is based upon the number of students going. **All students disqualified or unable to attend after October 16, 2026, will forfeit the initial deposit of \$120.** All refund requests must be submitted via email directly

to Mrs. McKenzie at susan.mckenzie@cabarrus.k12.nc.us. Once approved, the request will be sent directly to Emerald Student Travel to refund the student. If a student needs to cancel their trip prior to the final payment, they will be given a full refund, **minus the \$120 non-refundable deposit**, once approved for their extenuating circumstances. If a student becomes disqualified and/or needs to cancel their trip after the final payment is due, there will be no refund.

BEHAVIOR EXPECTATIONS

Participation in this trip is based upon students conducting themselves appropriately throughout the school year. A student who receives any of the following will lose his/her privilege to attend the Charleston, SC trip:

- Any Out of School Suspension (OSS) starting October 16, 2026, through the day of departure
- Students with In School Suspension (ISS) during the 2nd Semester
- More than 10 days unexcused absences for the year starting October 16, 2026, through the day of departure

CHAPERONES

Our chaperone group will consist of school staff and parents. Students will be assigned to a chaperone group. There will be approximately 10 students per chaperone. Students must stay with chaperones at all times! NO EXCEPTIONS!

If you are interested in being a parent chaperone, please send Mrs. Susan McKenzie a message on Parent Square by October 16, 2026. Interested parents will receive a link from Mrs. McKenzie to a form that must be completed. Each parent that is selected will be required to have an updated background check completed and will also be required to pay for his/her own cost of the trip. The chaperone price is \$438 and will have double occupancy. We anticipate more parents than needed so we will select parent chaperones by a random drawing. DO NOT MAKE CHAPERONE PAYMENTS UNTIL YOU HAVE HEARD FROM MRS. MCKENZIE THAT YOU HAVE BEEN SELECTED.

ITINERARY

Our itinerary will include the following events/activities:

- Patriots Point and the USS Yorktown aircraft carrier
- Charleston Museum
- Walking Tour in historic downtown Charleston
- Barrier Eco Tour
- Charleston Marketplace
- South Carolina Aquarium

ROOMING INFORMATION

There will be 4 students assigned to each hotel room. Each hotel room will have 2 full/queen sized beds which students will share among the 4 of them. All students who have paid will have the opportunity to choose his/her roommates. Students will choose roommates sometime in February. All rooming assignments will be reviewed by teachers and administrators. If any damage is done to the room by your child, it will be the responsibility of the parent/guardian to pay the damages to the hotel.

MEALS

All meals while on the trip are included in the total price of the trip. Students may want to bring snacks for the bus and at the hotel room.
